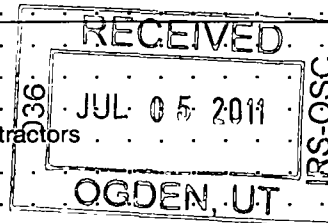

The corporation is formed for the following purposes:

(a) To operate exclusively for charitable purposes, including, for such purposes: (i) making need-based distributions and providing assistance to employees of Maxim Healthcare Services, Inc., a Maryland corporation, or their family members, adversely affected by a "qualified disaster", as defined in Section 139 of the Internal Revenue Code of 1986, as amended, (ii) making distributions and providing assistance to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, which provide relief, financial aid, assistance and disaster relief payments to disaster victims or to the poor or distressed, (iii) making need-based distributions and providing assistance to victims of disasters and their families and to the poor and distressed, and (iv) making distributions and providing assistance to other organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding section of any future federal tax code ("the Code").

(b) To engage in any lawful activities which are in furtherance of the purposes of the Corporation, but subject to the restrictions set forth herein.
