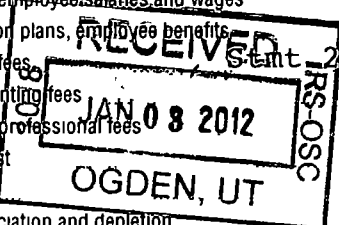

Per your request, Oracle Capital LLC ("Oracle Capital") has determined the Fair Market Value of a 6.25% member interest (the "Interest") in Series C Bonds Investments Management, LLC ("Series C" or the "LLC") as of January 1, 2010 (the "Valuation Date"), to assist you with gift tax reporting and planning. Based on the information in the detailed narrative that follows, our opinion of the Fair Market Value of the Interest on a non-controlling, non-marketable basis is:

FAIR MARKET VALUE (on a non-controlling, non-marketable basis) (in US\$)	
A 6.25% member interest as of January 1, 2010	\$175,000

The standard of value used is Fair Market Value. Fair Market Value is defined by Internal Revenue Service Revenue Ruling 59-60, CB 1959-1, 237 as:

"The price, expressed in terms of cash equivalents, at which the property would change hands between a hypothetical willing and able buyer and a hypothetical willing and able seller, acting at arm's length in an open and unrestricted market, when neither is under compulsion to buy or sell and when both have reasonable knowledge of relevant facts."

Fair Market Value is determined with the premise that Series C is a going-concern, or ongoing business enterprise with its management operating in a rational way to maximize value.



Our valuation contemplates the unique characteristics associated with the Interest. We considered and analyzed its value indicators, or the internal and external factors that influence its value. These factors include the income-producing capacity of Series C's assets along with national and local trends in the economy. Based on our analysis of Series C's assets and the economy we identified the risks associated with the Interest that impact its value. These risks are reflected in our calculations.

Valuations typically employ three approaches: cost, income, and market. We considered all three approaches in our valuation of the Interest. The Interest being valued is not able to exert complete control and is therefore valued on a non-controlling basis. Additionally, the determination of Fair Market Value usually considers the differences between a publicly-traded investment, and a private, or non-marketable investment. Because the Interest is privately-held, it is non-marketable and requires an adjustment for lack of marketability.

The following report ("Report") will provide a summary narrative of the methods, procedures, and calculations used to arrive at our opinion of Fair Market Value in conformance with the Uniform Standards of Professional Appraisal Practice ("USPAP"). The opinions expressed in this valuation are contingent upon the conditions set forth in the Statement of Assumptions and Limiting Conditions in Appendix 1 of this Report. Additionally, numerous assumptions are included throughout this Report. Therefore, you should consider the entire Report in order to obtain an understanding of our estimate of the Fair Market Value.
