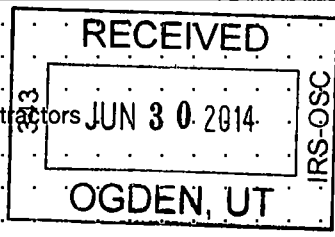

The World Ocean Council (WOC) is an international, cross sectoral industry leadership alliance on ocean environmental education in support of sustainability and stewardship. It brings together companies from industries dependent on ocean space and resources to catalyze leadership and collaboration in addressing marine environmental issues by improving the awareness and understanding of the marine environment. The WOC educates a wide range of ocean industries including shipping, offshore oil and gas, fisheries, aquaculture, tourism, offshore renewable energy, dredging, submarine cables and pipelines and others, to improve their awareness and understanding of marine environmental issues and contribute to the development of solutions to these problems through analysis and discussion of scientific research. Activities, and an estimated percentage of time spent by the WOC on each, include the following:

- (a) Educating ocean industries and raising awareness and communicating about marine environmental and science issues (20%)
- (b) Monitoring, analyzing, and reporting on ocean environmental and science policy developments (10%)
- (c) Providing conferences, seminars and other avenues of discussion with ocean stakeholders on marine environmental stewardship and science (30%)
- (d) Informing ocean users about the need for improving ocean science and developing science-based solutions to marine environmental issues (20%)
- (e) Encouraging ocean industries & other ocean users to improve environmental performance thru ocean stewardship strategies & best practices (20%)

In 2010, all of the above-described activities were carried-out by World Ocean Council as a project of its fiscal sponsor - Trust Conservation Innovation (EIN 91-2166435).
