CWEMD is committed to promoting quality residential and commercial development, implementing infrastructure and beautification projects, improving security, marketing the area to new residents and visitors, and finding funding sources for neighborhood improvement projects. The contribution to CWEMD will be used to fund community services, infrastructure, security, planning and transit facilities in the Central West End/Midtown area.
