Form 990 Section Note The annual pay-out for the two annuities is \$7,840. from the separate account described in Schedule D, Part IV. Based on the Publication 939 tables the estimated future liability is approximately \$83,000. Using life expectancy tables published by the Social Security Administration the estimated future liability is approximately \$63,200 assuming that the 80 year old annuitant in the joint annuity survives the 84 year old.
