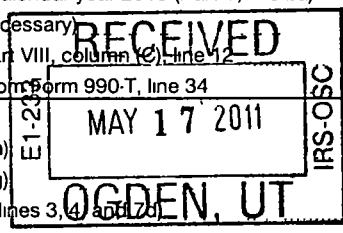

**THIRD:** The Corporation is organized exclusively for charitable, educational and scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code"), or the corresponding section of any future federal tax code, and in this regard to increase and improve the availability and quality of, and access to, sufficient transportation services for senior citizens and other mentally and/or physically disabled persons in Northeast Ohio; and in furtherance thereof, to:

- 1) To provide paratransit services to senior citizens and other disabled persons;
- 2) To coordinate and/or manage a network of service providers dedicated to providing paratransit services to senior citizens and other disabled persons;
- 3) To act as an advocate for transportation services for senior citizens and other disabled persons;
- 4) To serve as a clearing house for information about transit and paratransit resources in Northeast Ohio;
- 5) To educate and provide planning assistance to service providers regarding system design and implementation in order to facilitate use of existing transportation systems by senior citizens and other disabled persons;
- 6) To apply for and coordinate grant funding and capital needs planning to facilitate systematic and needs appropriate acquisition and replacement of vehicles used for transportation of senior citizens and other disabled persons; and
- 7) To formulate and encourage the implementation of uniform qualifications, training requirements and other standards designed to improve the quality of transportation services for senior citizens and other disabled persons.

In furtherance of the above-stated purposes, the Corporation shall have and may exercise all powers of a nonprofit corporation under the laws of the State of Ohio including, without limiting the generality of the foregoing, the power to accept, hold, invest, reinvest, administer, use, disburse or donate any gifts, donations, bequests and grants of money and property from public or private sources, to acquire other real and personal property, by purchase or otherwise,

to incur debt and liabilities, to enter into other contractual obligations with public or private entities, and to do all things necessary or appropriate in order to accomplish the foregoing purposes.

**FOURTH:** The Corporation shall have the power, either directly or indirectly, either alone or in conjunction or cooperation with others, to do any or all lawful acts and things and to engage in any and all lawful activities which may be necessary, useful, suitable, desirable or proper for the furtherance, accomplishment, fostering or attainment of any or all of the purposes for which the Corporation is organized, and to aid and assist other organizations whose activities are such as to further, accomplish, foster or attain any of such purposes. Notwithstanding anything herein to the contrary, the Corporation shall exercise only such powers as are in furtherance of the exempt purposes of organizations set forth in Section 501(c)(3) of the Code and the regulation thereunder, or the corresponding section of any future federal tax code.

**FIFTH:** All of the funds and assets of the Corporation, together with the net earnings thereof and income realized thereon, shall be exclusively devoted to the purposes hereinabove expressed, and no part of its net earnings shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article THIRD hereof.

**SIXTH:** In carrying out its purposes and in exercising the powers granted to it by law, the Corporation shall be subject to the following restrictions, namely, (i) no substantial part of its activities shall consist of carrying on propaganda, or otherwise attempting, to influence legislation, (ii) it shall not participate in, or intervene in (including the publishing or distributing of statements), any political campaign on behalf of or in opposition to any candidate for public office, and (iii) notwithstanding any other provision of these Articles, it shall not carry on any other activities not permitted to be carried on (A) by a corporation exempt from federal income tax under Section 501(c)(3) of the Code, or the corresponding section of any future federal tax code, or (B) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Code, or the corresponding section of any future federal tax code.

**SEVENTH:** In the event of any voluntary or involuntary dissolution or liquidation of the Corporation, or in the event of failure to reinstate these Articles after cancellation thereof, any remaining assets of the Corporation, after making provisions for discharge of all of the liabilities of the Corporation, shall be paid over and distributed to another charitable organization described in Section 501(c)(3) of the Code, or the corresponding section of any future federal tax code, as determined by the directors, or to a governmental body or agency, to be used exclusively for the purposes stated in Article THIRD of these Articles or, in the event such purposes cannot be fulfilled, designated public purposes.
