KOM achieves this mission by: 1) assisting refugees to settle, integrate and become increasingly self-sufficient; 2) fostering cultural knowledge and understanding, and 3) strengthening organizational capacity and effectiveness to meet the needs of the community.

Under the Refugee Social Services (RSS) grant, the grantee consortium strives to achieve specified outcomes in four areas, in three of which KOM provides services: (1) refugee families have stable housing, (2) refugees have adjusted their immigration status (KOM does not handle this one); (3) refugee families are engaged with community services and programs; and (4) refugee families are independently functioning. KOM served 408 clients under the RSS program in 2010.

**4b** (Code: ) (Expenses \$ 55,190 including grants of \$ 0 ) (Revenue \$ 0 )

Under the Refugee Employment Services (RES) employment services grant, KOM strives to place clients in jobs and/or enroll them in short term vocational programs. KOM served 313 clients under the RES program in 2010.

**4c** (Code: ) (Expenses \$ 112,954 including grants of \$ 0 ) (Revenue \$ 0 )

Under the Ethnic Self-Help grant from Office of Refugee Resettlement (ORR) (1) KOM will connect Karen and other refugees from Burma to mainstream community resources; (2) KOM will facilitate the cultural adjustment and integration of Karen and other refugees from Burma by assisting Karen to obtain job training, employment and/or enroll in ESL; and (3) KOM will deliver mutually supportive functions such as information exchange, civic participation, resource enhancement, orientation and support to refugees from Burma. KOM served 386 clients under the ORR program in 2010.
