Heshima has one program service at this time which is providing physical therapy, occupational therapy and speech therapy to 15 children ages 5 to 13 that have cerebral palsy, brain damage, and other disabilities. All the children come from very needy and poor families. Each child receives occupational therapy and physical therapy three times a week as well as hot breakfast and lunch each day they are getting therapy. Also, there is a speech therapist that comes to the center one time each week to work with each child. We provide another form of therapy, horseback riding, which helps strengthen the children physically and improves balance and coordination. Heshima provides the children and parents with nutrition and medical support by periodically bringing in local doctors and nurses to teach them better habits.

Each child that comes to our center has needs in all these areas. We believe that the body and the mind work together.

We have seen great results from the therapy, especially in our kids that have Cerebral Palsy.
