 Global Programs include the ONE Prayer program (with a total of approximately \$60K toward indigenous church-planting in the nation of India in 2010/2011) Starting in 2007, the ONE Prayer program helped steward the resources necessary to plant more than 3,700 churches across India, Cambodia, Sudan and China, with those established networks continuing to plant and replicate beyond the bounds of the project's initial scope and timeframe In addition, EnterMission has helped to provide various community development initiatives in India as a component of the holistic church planting methods that Entermission coaches (including the provision of clean water, literacy and education resources, construction programs for housing and community health/sanitation, health and hygiene education, etc) Finally, The Rhema Project (TRP), which exists as a project of EnterMission to intercept and halt the practice of female infanticide/feticide in Southern India, reports that in the past calendar year, it has successfully supported 254 orphaned girls in foster care or baby homes, provided for the rescue of 15 girl infants, provided clean water and increased income for at-risk families (including 2 bore wells, a 50% increase in teacher pay and enrolling 20 into nursing assistant training), and increased agricultural yields through drip irrigation projects on test plots of 1/4 acre

 Local Programs include a food pantry that served approximately 350 different families Training and education programs include The Gathering which offers 60-75 residents a hot meal and spiritual conversation each week The Son City Kids program (including Son City Teens, Summer, After School, and Kids) operates at various times throughout the month to offer approximately 188 kids learning opportunities outside of school including mentoring, tutoring, social and ongoing spiritual development opportunities GED program offers 135 individuals courses that will help them complete high school and take the high school equivalency exam Prison transition/addiction care program helps 15-20 men learn habits that better enable them to re-enter society after completing their prison sentence The greenLockers program collected 16,000 pounds of school supplies from 15,000 students in 34 area schools and distributed those supplies to 40 charities
