The Homeless Families Foundation makes a difference in the lives of families through programs that provide the stability needed to acquire jobs, housing, and a chance at a better life. HFF has 46 fully furnished apartment shelter units. We provide case management to help our families regain support and stability on their paths to permanent housing. In 2010, HFF served 217 families and 470 children with 85% of the families finding and maintaining their own housing. The average length of stay at our shelter is 99 days.

The Homeless Families Foundation has a strong focus on helping children succeed in school and life by providing an after-school and all-day summer program for school-age children. In 2010, the Dowd Center served 160 school-age children and provided tutoring, enrichment, homework assistance and recreational activities. The Dowd Center collaborates with many community organizations to provide the enrichment opportunities for our children.
