IN FURTHERANCE OF THE MISSION, TRANSPLANT FOUNDATION THROUGH THE GIFT OF LIFE INSTITUTE CONDUCTED FORTY-SEVEN (47) WORKSHOPS AND/OR CONSULTING OPPORTUNITIES IN 2010, COVERING FAMILY COMMUNICATION AND CONSENT FOR ORGAN AND TISSUE, HOSPITAL SERVICES STAFF DEVELOPMENT, WITH MORE THAN 700 PROFESSIONALS PARTICIPATING IN THOSE 2010 TRAININGS. THE GIFT OF LIFE INSTITUTE ALSO HOSTED SIX (6) AFFILIATED ORGANIZATIONS WITH MORE THAN 200 ADDITIONAL PROFESSIONALS RECEIVING INFORMATION ABOUT THE IMPORTANCE OF DONATION AND TRANSPLANTATION. IN ADDITION, THE INSTITUTE HAS TAKEN A NATIONAL LEADERSHIP POSITION BY JOINING FORCES WITH THE ORGAN DONATION AND TRANSPLANTATION ALLIANCE AS A PARTNER IN PROVIDING EDUCATIONAL OPPORTUNITIES TO ORGAN AND TISSUE DONATION AND TRANSPLANTATION PROFESSIONALS THROUGHOUT THE UNITED STATES. THE INSTITUTE IS ALSO A MEMBER OF THE HRSA DONATION AND TRANSPLANTATION COMMUNITY OF PRACTICE LEADERSHIP TEAM. SINCE ITS INCEPTION, THE INSTITUTE HAS WORKED WITH OVER 13 COUNTRIES TO SUPPORT DONATION AND TRANSPLANTATION INITIATIVES. TEAM PHILADELPHIA. IN 2010, THE FOUNDATION CONTINUED ITS CO-SPONSORSHIP COORDINATION, ALONG WITH GIFT OF LIFE DONOR PROGRAM OF THE "TEAM PHILADELPHIA" ENTRY TO THE "U.S. TRANSPLANT GAMES." THE PURPOSE OF THE TRANSPLANT GAMES IS TO INCREASE AWARENESS THAT TRANSPLANTATION IS SUCCESSFUL, TO INCREASE PUBLIC AWARENESS AND COMMITMENT TO ORGAN DONATION BY ENCOURAGING PEOPLE TO DISCUSS THEIR FEELINGS ABOUT ORGAN DONATION WITH THEIR FAMILIES, TO RECOGNIZE THE FAMILIES WHO DONATE THE ORGANS AND TISSUES FROM THEIR LOVED ONES EACH YEAR, AND TO PROVIDE AN EVENT THAT FOSTERS THE SUCCESSFUL REHABILITATION OF ALL PATIENTS WHO HAVE RECEIVED ORGAN AND TISSUE TRANSPLANTS. THE ATHLETES ACT AS TORCHBEARERS FOR THE MORE THAN 100,000 AMERICANS WHO ARE WAITING TO RECEIVE TRANSPLANTS, AND THEIR SECOND CHANCE AT LIFE DUE TO THE CRITICAL SHORTAGE OF DONATED ORGANS FOR TRANSPLANT. THE TRANSPLANT GAMES ARE ALSO A CELEBRATION OF LIFE AMONG THE RECIPIENTS, THEIR FAMILIES, AND THE FAMILIES OF DONORS. THE 2010 GAMES WERE HOSTED IN MADISON, WISCONSIN AND TEAM PHILADELPHIA HAD OVER 350 REPRESENTATIVES IN ATTENDANCE. DASH FOR ORGAN AND TISSUE DONOR AWARENESS. IN 2010, TRANSPLANT FOUNDATION ALSO SUPPORTED AND COORDINATED THE 15TH ANNUAL DASH FOR ORGAN AND TISSUE DONOR AWARENESS. THE 2010 DASH FOR ORGAN DONOR AWARENESS WAS HELD ON SUNDAY, APRIL 18 INVOLVING MORE THAN 6,000 PARTICIPANTS AND RAISING MORE THAN \$360,000 TO SUPPORT THE MISSION OF THE FOUNDATION. THE DASH INCLUDES A 10K RUN, A 5K RUN AND A 3K WALK IN AN EVENT HELD AT THE BASE OF PHILADELPHIA ART MUSEUM AND ALONG THE WEST RIVER DRIVE. THE EVENT RAISES AWARENESS, AS WELL AS FUNDRAISING FOR PROGRAMS SUPPORTING ORGAN DONATION AND TRANSPLANTATION FAMILIES, AND THE 2010 U.S. TRANSPLANT GAMES ENTRY FOR TEAM PHILADELPHIA. SCHEDULE OF TRANSPLANT FOUNDATION PROGRAM SERVICES. GIFT OF LIFE INSTITUTE TEAM PHILADELPHIA - U.S. TRANSPLANT GAMES HELD FROM JULY 31-AUG 3, 2010 IN MADISON, WI. TEAM PHILLY ORGANIZATION MEETINGS AND TEAM PRACTICES CONDUCTED IN THE SPRING AND EARLY SUMMER OF 2010, CULMINATING IN ATTENDANCE AT THE EVENT. 15TH ANNUAL DASH FOR ORGAN AND TISSUE DONOR AWARENESS - DASH FOR ORGAN AND TISSUE DONOR AWARENESS WAS ON SUNDAY, APRIL 18, 2010.
