The organization's primary purposes was to establish the permanent place of Buddhism worship, teaching Buddhist scripture, providing religious solace to all Buddhist disciples, counseling, religious instruction, chanting, and meditation.

We are now offered the full Buddhist library to the public and it opens everyday.

It has a regular congregation on the weekdays about 15, and on the regular weekend, a regular congregation is about 90. On the special religious days, the congregation is about 300.

Those special religious days are:

1. NEW YEAR: The celebration days are December 31, and January 1. They are national holidays for Thai, Laos and Cambodia. Religious ceremony includes chanting, meditating your mind, evaluating yourself what had you been behaving in the past year, set up new resolution to do good things in the coming year, and ask the good ness of Buddhism to help you to attain the goal that you promise to Lord Buddha.
2. SONGKRAN FESTIVAL: It is the celebration of old New Year based on the lunatic calendar. It starts with religious ceremony by the monks. It is the day of pouring water to each other as a symbol of love, good wishes of tranquility to others. The days of celebration are April 12-14.
3. KHAO PANSA FESTIVAL: Back more than 2550 years ago, Buddhist proclaimed that all the monks should go through an intensive study Buddhism, chanting and meditation for three months. They were prohibited to travel but stay put at the monasteries that they belong to during the period. The festival is to remind people that if they should do the same in term of chanting and meditation and do only good deeds. This festival takes places in July.
4. KHATIN FESTIVAL: This festival is for the public to offer clothes and other basic needs for day to day living to monks who were limited to stay in one place for three months under 3 above. This takes place sometimes in October
