The impact of our grants and work in the "prevention of family violence" service area helped reduce the health risks faced by
victims of family violence. This service area empowers communities in Ohio to build coalitions that create comprehensive
plans for breaking the cycle of family violence that threatens the physical, emotional, and social well-being of people of all
ages, including the elderly. The focus is on stopping it before it happens.

The "preventative oral health care" service area supports projects that improve access to preventative oral health care,
strengthen the capacity of safety net providers and encourage community-based prevention strategies. Oral health is the
top unmet health need of all Ohioans and, while Medicaid promises a health safety net for the poor, there is virtually no
safety net when it comes to dental care. Our grants and strategies have helped Ohio's poor receive dental care that they
otherwise might not receive.
