They are scored in 8 separate areas by at least 3 reviewers. The top applicants are awarded a \$3,000 scholarship and outstanding candidates receives a \$5,000 scholarship. The scholarship is renewable for 3 years, requiring a copy of the candidate's transcript to substantiate GPA and a minimum of 12 credits per semester and a personal letter from the student. The Foundation also provides for \$1,000 vocational scholarships. All applicants are reviewed by the Hawaii Community Foundation which submits a list of candidates to the Foundation for final selection. Checks are issued to the schools of the selected scholars.
