



In addition, it leases office space at 1659 Scott Blvd., Suite 4, Santa Clara, California, and leases premises for providing dental care to handicapped patients at Montpelier Drive, Suite 3, San Jose, California. Patients are primarily uninsured children from low income families throughout California. During the fiscal year ended December 31, 2010, over 6,904 dental visits were completed to 2,964 patients.
