Throughout the season the Blue Jackets franchise donates Hats for Heroes hats to local and statewide pediatric cancer organizations. The hats are donated under the NHL Hockey Fights Cancer initiative which asks all NHL hockey teams to get involved with local cancer organizations. These hats are donated directly to children and their families whereas the autographed merchandise is reserved for local non-profit groups to utilize in silent and live auctions for their fundraising efforts.
