Training facilities in Brazil -Instituto Socio-Educacional pro-Ciudadania, (ISEC) Rio de Janeiro, BrazilThe translation meaning Pro-Citizen Social-Educational Institute, the ISEC's Programa Abrigo (Refuge Program) is a home for approximately 80 children and young adults Orphaned Starfish has provided funds for the furnishings and operational expenses of three vocational training rooms in three homes The children use the training rooms to learn fundamental computer and internet skills and increase their level of literacy OSF also supplied a grant for multimedia and educational training for the mentally and/ or physically handicapped children - Centro Estudos e Aes Solidrias da Mar (CEASM), Rio de Janeiro, BrazilCEASM is an organization serving the community of Mare in Rio de Janeiro Founded by the inhabitants of Mare, with an objective to improve the poverty conditions they face CEASM provides access to culture, technology, and other influences otherwise not available to the inhabitants of Mare In order to achieve their goal, they provide courses in foreign languages, computing, reading, photography, video, music, theater, etc The OSF provided resources to acquire computers and install wiring in the computer room Fundacao Americo de Viveiros, Rio de Janeiro, BrazilFundacao Americo de Viveiros (American Foundation of Life) is an organization that provides vocational training for children living in the Favela of Turano OSF has funded the acquisition of twelve computers, a printer and a scanner for the home's existing computer room The foundation will also provide funds on a continuing basis, to supply children attending classes with a nutritional lunch Centro de Aes Integradas Novo Horizonte, Rio de Janeiro, BrazilCentro de Aes Integradas Novo Horizonte (Center of New Horizons) is the home of approximately ninety children ranging from infants to 14 years old All the children receive education at the facility Children older than 14 years attend classes to receive job training in silk printing techniques, from design to final product The OSF funded the acquisition of computer equipment and peripherals, including classroom supplies In addition, the foundation provides funds, on a continuing basis to supply a nutritional lunch for the children attending lessons at the facility
