AT THE END OF 2010 OHCA HAD 737 MEMBER FACILITIES WITH 58,177 BEDS, ALONG WITH 294 ASSOCIATE MEMBERS. THE MEMBERSHIP INCLUDED 79 ICFS/MR AND 159 ASSISTED LIVING COMMUNITIES.
