Grant Funds were given to United Methodist church agencies for the accomplishment of volunteer work requested. Such Funds were used to purchase materials and install temporary RV hook ups at work sites for NOMADS volunteers. NOMADS volunteers worked 173 three week projects, donating 108,700 hours of volunteer work. Estimated Labor value was \$2.2 million.

4b (Code:) (Expenses \$ 81,700 including grants of \$ 0) (Revenue \$ 0)

Providing a central clearing-house to match volunteers with mission opportunities, and organize the volunteers for short-term work in missions. This is the main function of the contracted duties of the NOMADS program Administrator. Over 1000 members volunteered to work 173 projects short-term and two disaster response areas in 2010.

4c (Code:) (Expenses \$ 0 including grants of \$ 12,903) (Revenue \$ 0)

Disaster Relief response providing grants and assistance to victims of Hurricane Katrina in Mississippi and Hurricane Ike in Galveston, TX. NOMADS volunteers worked 11,303 hours at these disaster sites.
