Part VI, Section B, line 12b \*\* --- The organization regularly and consistently monitors compliance with conflicts of interest by routine meetings attended by all trustees and key employees. The nature of the organization's activities is such that conflicts of interest are not likely to occur.

Part VI, Section B, line 15b --- None of the organization's trustees or officers are compensated for services. The only employee, a "key" employee, is paid as a minister in accordance with IRS rules, regulations and other guidance. His compensation is set by trustees after careful consideration of responsibilities, expectations and comparability data; and contemporaneous substantiation of the deliberation process and decision is made.

Part VI, Section C, line 19 --- All records of the organization are available to the public for inspection if the inquiring person has an interest in supporting the organization's mission or there is otherwise a need to know.

Part XII, question 1 --- The corporation has not recorded depreciation, but otherwise follows GAAP (accrual) in all material respects

\*\* This answer is provided even though "No" is the correct response to question 12a. The nature of Lehman Avenue Evangelize Kentucky, Inc. is such that a whistle-blower policy is considered by all trustees as unnecessary. Additionally, there is no document retention and destruction policy other than the policy to maintain records suitable for compliance with IRS rules, regulations and requirements for record-keeping purposes.
