Mobilized churches and individuals to put their faith into action: Worked with members of more than 50 USA churches & hundreds of individuals in 2010 to facilitate and advance the gospel and teaching of Jesus Christ, to the extreme poor in areas of greatest need throughout the world. We maintained and improved relationship and service to many of these churches, and also added a number of new churches choosing to minister with us. We aided our partner churches with encouragement, creative ideas, opportunities and facilitation to partner with other churches and Christian missions and relief organizations, service and vision trip organization and training, child sponsorship campaigns, and raising funds for many specific spiritual and compassionate causes in their church and across the world. The results included a great many individuals and their churches coming alive in their faith and serving both with the poor of the world and here in the USA. It also resulted in significant financial giving directly to the missionary and Christian relief organizations that they became connected with. This included things like continuing and growing long-term support for more than 5,500 needy children, through World Vision Child Sponsorships campaigns conducted at church partners by inspired and equipped volunteers who have participated in the organizations programs. (An example of how we facilitate spiritual and material facilitating spiritual and material support for the mission partners and organizations we connect with, with more shown below)

 - Organize and lead mission trips: More and more we are facilitating and assisting churches in organizing and accomplishing mission trips that are not run through our books. We help recruit, train, and send the leaders and teams of these trips and work closely to help arrange the details, ministry partnership, and subsequent follow-up. We continue to take a leader roll with some of trips as well. A number of trips to work with the poor in Africa, as well as India, Cambodia, Thailand were included in 2010. One major trip to Malawi Africa involved more than 100 people over a 5 week period. This included working with 5 strategic ministry partners involved with Y-Malawi, gospel teaching in villages, schools, and churches, a medical team of doctors and nurses serving in the Nkhoma Hospital, improving food production through the creation of "Farming God's Way" model farming plots, continuing construction of Fishers Trainers Senders Ministries training center, visiting World Vision sponsored children in their villages, provided leadership training and coaching to village Chief's, Pastors, and school teachers, and much, much more.
 - Inspired unpaid volunteers raised funds and served to help organize and achieve these accomplishments.
 - Completed 10 trips in 2010, enabling pastors and lay leaders to learn ministry needs first-hand, work and serve on the front-lines, with more than 175 participants and completion of a wide variety of ministry projects in several countries.

Provided volunteer leadership for Y-Africa/Y-Malawi ministry movement, including mobilizing USA churches as well as African projects, partners, and trips. FaithQuest has aided in connecting and maintaining relationship with 27 USA churches for this movement. The programs and projects have included child sponsorship and support, water wells, agriculture and food security initiatives, health and hygiene programs, schools plus education & literacy projects, economic development through micro-finance, youth ministry, orphan and vulnerable children projects, HIV and malaria related initiatives, and diverse evangelism and discipleship programs to advance the love and teachings of Jesus Christ.

- For the above 4a, 4b, 4c, expenses and revenue are not allocated separately to each of the many programs
- The vast majority of FaithQuest programs are accomplished by recruiting, inspiring, and equipping volunteers in the local church who in turn work with us and their churches and the Christian missions and relief organizations we introduce to them. In 2010 well over \$3,000,000 USD in identifiable mission & relief action for the lost, poor, sick, thirsty, hungry, children and widows resulted.
