Project Hawai'i Teen Mentoring Summer Camp. This camp is 3-fold providing a day camp, sleepover camp and mentoring program. The camp is offered free of charge to children meeting our mission between the ages of 3-7, and teens enrolled in high school. We provide all their fundamental camp needs from sleeping bags, swimsuits, shoes, food, hygiene, etc. The Adventures Abound Day camp allows children to travel the island learning about the wonders of the ocean, coral reefs, volcano, nature, planting gardens, exploring the skies. Places that would otherwise be out of their financial reach. The Edu-Camp sleepover session allows the children to grow on a different building self-esteem, life skills and social behavior that will help them develop and make friendships in school. The activities are based educational programs that are sometimes left out of school curriculum due to budget cuts, such as music, Hawaiian culture, science, etc. Our teen mentors work along side the little one's guiding them through the planned activities. They gain leadership and mentoring skills. Earning up to 200 community service hours and of course a new sense of themselves that will help them take on challenges in their future. This camp is fully run by volunteers and invite the community to share their talents for a day, or be involved as their practicum requirement. The graduation allows for the children to receive their new backpacks filled with school supplies, new outfits and shoes to go back to school.

Christmas Party/Deliveries: Our volunteers provide a holiday party on the island of Hawai'i for over 350 children living in poverty or in homeless situations. The children attend the party with their parent(s) for an evening of fun. Santa arrives takes his photos with the children and gives them a special holiday gift that was donated by the public's sponsorship. The children and their family are able to enjoy a hot nutritious holiday meal. The children play games that provide prizes that will help in their every day living. They win shoes, blankets, hygiene products, books, and other great donations for the community. The children also make crafts they use to gift their friends, family and even teachers. Decorating their own cookies and other activities help them to feel normal for one evening and build their self-esteem. On the island of O'ahu our volunteer elves deliver packages to the children living along the beaches in both Waiānānae and Waimanalo. The elves will deliver on Christmas day with packages all wrapped up for each child. Also providing holiday meals for their family. Most of our children are sponsored by the local companies displaying a "keiki wish tag" board allowing for the public to sponsor a keiki and we conduct collection and toy drives across the islands to assure that no child goes without the wonders of the holidays.

Emergency Outreach/Awareness
Our volunteers dedicate one or two weekends a month to assure that the children living in poverty are being cared for and not forgotten. Their situations change daily, and we don't want to lose track of where they end up moving to. Our volunteers deliver hygiene, food, clothing to the children during the outreach weekends. Going deep into the bushes, high in the hills, or across the ocean's beaches to find the children. Last year we were able to provide services to over 1,500 children living in crisis.
Our awareness outreach includes participating in local fairs, venues, street awareness and partnering with the schools to help us reach our goals and getting the community involved in the solutions.

We do not inventory our donations as maybe a charity with a store, or warehouse situation. We primarily have the childrens needs printed, and then filled. Misc. items that might come in are give as prizes, or away at our outreach program and are not inventoried in a bookkeeping manner.

For example: If someone donated us a large box of misc. clothing and toys at the give away, we do not sort through it. We put the items on the table for the children to take. The value is then estimated by size, etc. or if a donor brings us 100 boxes of crayons to the party, we give them as prizes, but do not keep an official record for our books, rather we estimate the value of the entire prizes for the party.

Typically, the group signed up to help us collect funds, products, etc. will be given a kiki wish board, or list of items needed to sponsor a child. Then the group will give us the items they have donated. Some of them keep great records and others do not. We do know what we need in order to complete our mission at hand, however we do not keep track of the "extra items" and they are give to those in need at the outreach events.
