In partnership with the U.S. Forest Service, the PCTA works to preserve the PCT by  
leading and coordinating trail maintenance, construction and reconstruction projects.

While many resources make up the PCT experience, the trail tread provides access.

The Trail requires constant effort to keep it safe and passable. Work involves  
cutting back annual growth, removing fallen trees, and repairing the annual damage of  
floods, fire and natural deterioration.

PCTA received a very generous, two-year grant through the American Recovery and  
Reinvestment Act, more commonly known as the federal stimulus or ARRA. Through the  
U.S. Forest Service (USFS) and Bureau of Land Management (BLM), PCTA received  
\$947,084 in ARRA dollars for 2010 and 2011. We spent about \$470,000 of that in 2010.

We leveraged that federal money to get the most value for taxpayers, the Pacific  
Crest Trail (PCT) and the hiking and horseback-riding public and proved our

We hired seven full-time and two seasonal employees to coordinate with the government agencies on the trail work that needed to be done and to oversee the projects in the field. These are two-year positions. For years, we have had to prioritize a backlog of trail maintenance, and this stimulus funding allowed us to tackle many important and overdue projects. These new staff members, along with our existing trail maintenance experts, oversaw both volunteer and corps crews that tackled more than 380 separate trail maintenance and reconstruction projects in 2010. The ARRA funding supported the PCTA's Windigo Trail Crew and allowed the PCTA to partner with other ARRA-funded crews, including EarthCorps, Northwest Service Academy's AmeriCorps, Northwest Youth Corps and Student Conservation Association. The ARRA-funded corps crews and volunteers contributed 68,854 hours to the trail in 2010.

These programs contributed significantly toward helping the PCTA increase its total volunteer hours by 68 percent -- from 81,286 hours in 2009 to 136,155 hours in 2010, including 132,447 hours of trail work on 914 miles of the PCT. That equates to an in-kind value of more than \$2.8 million -- a record in the number of volunteer hours our organization logged both on and off the trail in a single year. We're hoping to equal that in 2011.

From the beginning of the stimulus grant process, we knew it was temporary money. So we focused on strengthening our volunteer base, training new crew leaders, and putting new crews together. We increased our focus on youth in an effort to not only provide worthwhile outdoor programs for young people, but to build future stewards of the PCT. In 2010, 60% of our volunteer hours were accomplished with youth corps and other youth programs

For volunteers to be successful in their trail maintenance efforts, they need education, training, and oversight in trail construction and maintenance. PCTA trainings offer new volunteers an opportunity to learn basic restoration and safety while experienced volunteers improve their restoration skills in advanced training sessions. In 2010, PCTA sponsored 21 training sessions. This included four Trail Skills College events, with 340 volunteers attending weekend long trainings with classroom and on-the-trail sessions to help them become more effective trail crew members and leaders.

We also had much success in 2010 with our goals of increasing awareness of the PCT and the PCTA. We capitalized on National Geographic's release of its PCT film, combining information and outreach events with several screenings. We continued to publish our quarterly magazine, the PCT Communicator and added new ways to reach out to our members and the public. We are now sending regular electronic newsletters to our members and are using our Facebook page to engage the online trail community.

The PCT experience is an opportunity for people to leave behind their typically human dominated world and find respite in an environment dominated by the forces of nature. Whether users are out for an evening stroll or a long distance backpack, PCTA strives to provide the best possible experience for Trail users. A good deal of the PCT has an excellent wilderness setting, although many miles are in non-wilderness areas. The Trail makes its way through the most natural corridor possible, avoiding intrusions.

While our trail maintenance program is always highly visible and its accomplishments easy to quantify, it's more difficult to measure our efforts to protect the Trail.

As our Trail Operations team manages the daily maintenance workload, it also works behind the scenes with our agency partners to monitor and react to threats to the Trail from proposed logging operations, road construction proposals, pipeline and other utility projects and off-road vehicle infringements, among other things. And we continue our ongoing efforts to ensure that the Trail is located in the proper place along the Pacific Crest with the goal of optimizing the trail experience for all users.

We kicked off our land acquisition program in 2010 with the long-awaited deal on the Keene Creek property in Southern Oregon, which created a never-ending conservation easement that protected a crucial mile of the PCT.

Protection activities also include the PCTA's work to advocate for federal funding
