THE LA JOLLA INSTITUTE IS A NONPROFIT BIOMEDICAL RESEARCH INSTITUTE DEDICATED TO FIGHTING DISEASE THROUGH CUTTING-EDGE IMMUNOLOGY RESEARCH SPECIFICALLY, OUR RESEARCHERS FOCUS ON UNDERSTANDING THE IMMUNE RESPONSE TO INFECTIOUS DISEASES AND CANCERS AND TO ADVANCING PROGRESS TOWARD THE PREVENTION, TREATMENT AND CURE OF NUMEROUS DISEASES RELATED TO IMMUNE SYSTEM FUNCTION IMMUNE SYSTEM DISORDERS AFFECT MILLIONS AND INCLUDE MANY OF SOCIETY'S MOST DEBILITATING ILLNESSES (SEE SCHEDULE O FOR CONTINUATION) OUR RESEARCH FOCUSES ON FIVE MAJOR DISEASE AREAS 1 AUTOIMMUNE DISEASES SUCH AS TYPE 1 OVERSEES RESEARCH EFFORTS TO ANALYZE IMMUNE SYSTEM FUNCTIONING SUPPORTING THESE EFFORTS ARE THE INSTITUTE'S MORE THAN 300 EMPLOYEES -- NEARLY HALF OF WHOM HOLD DOCTORAL DEGREES (PH D OR M D ) FROM NUMEROUS COUNTRIES AROUND THE WORLD ALTHOUGH RELATIVELY YOUNG, THE INSTITUTE HAS ACCOMPLISHED MUCH IN ITS SHORT HISTORY, AND WAS RECENTLY RANKED AMONG TOP FIVE ORGANIZATIONS FOR RESEARCH IMPACT IN IMMUNOLOGY WORLDWIDE (AS MEASURED BY CITATIONS PER PUBLICATION) BY THE RATING AGENCY THOMSON REUTERS IN ADDITION, THREE OF ITS SCIENTISTS ARE AMONG THE MOST HIGHLY CITED IMMUNOLOGISTS IN THE WORLD -- A DISTINCTION HELD BY LESS THAN ONE HALF OF ONE PERCENT OF ALL PUBLISHING SCIENTIFIC AUTHORS SEVERAL OF ITS FACULTY MEMBERS ALSO SERVE ON NATIONAL INSTITUTES OF HEALTH (NIH) GRANT REVIEW PANELS, APPOINTMENTS THAT SIGNAL A HIGH DEGREE OF RESPECT FROM PEERS ITS SCIENTISTS ALSO REGULARLY PUBLISH RESEARCH PAPERS DESCRIBING THEIR LATEST FINDINGS, MANY OF THESE APPEARING IN THE MOST PRESTIGIOUS CLINICAL INVESTIGATION, AND DR SUJAN SHRESTA'S RESEARCH, WHICH PROVED A LONG-HELD AND CONTROVERSIAL HYPOTHESIS THAT SOME ANTIBODIES CAN BE HARMFUL IN DENGUE VIRUS INFECTION HER WORK, PUBLISHED IN CELL HOST & MICROBE, IS INFLUENCING DENGUE VACCINE DEVELOPMENT WORLDWIDE IN ADDITION, FIVE POTENTIAL THERAPIES, BASED ON INSTITUTE DISCOVERIES, ADVANCED IN THE PHARMACEUTICAL PIPELINE IN 2010, THREE OF THEM IN CLINICAL TRIALS THESE INCLUDE ONE TRIAL BEING LED BY INSTITUTE SCIENTIST DR JOEL LINDEN ON SICKLE CELL DISEASE, A DEVASTATING DISEASE THAT AFFECTS SEVERAL MILLION PEOPLE WORLDWIDE OTHER MAJOR HIGHLIGHTS IN 2010 INCLUDED THE INSTITUTE'S RECEIPT OF A \$12.6 MILLION NIH GRANT TO DEVELOP AN RNA INTERFERENCE (RNAI) CENTER FOR GENETIC TESTING RNAI IS A NOBEL PRIZE-WINNING TECHNOLOGY THAT ALLOWS SCIENTISTS TO EXPLORE NEW WAYS OF DISRUPTING DISEASE PROCESSES BASED ON ALTERING GENE FUNCTION IN RECEIVING THE CENTER GRANT, THE LA JOLLA INSTITUTE SUCCEEDED IN A HIGHLY COMPETITIVE GRANT PROCESS, WHICH INCLUDED THOUSANDS OF APPLICATIONS ENCOMPASSING ALL BIOMEDICAL RESEARCH DISCIPLINES THE CENTER, SLATED TO OPEN IN 2011, WILL BE ONE OF A SMALL, SELECT GROUP OF DEDICATED RNAI FACILITIES WORLDWIDE ALSO IN 2010, THE INSTITUTE'S INFECTIOUS DISEASE EFFORTS CONTINUED TO MAKE IMPRESSIVE GAINS A TEAM OF LA JOLLA INSTITUTE RESEARCHERS ARE CHARTING NEW TERRITORY IN THE WORLDWIDE SCIENTIFIC BATTLE AGAINST TUBERCULOSIS, A DANGEROUS INFECTIOUS DISEASE THAT KILLS ABOUT 1.7 MILLION PEOPLE WORLDWIDE EACH YEAR AS PART OF A MULTI-MILLION DOLLAR PROJECT, FUNDED IN 2009 BY THE NIH, INSTITUTE RESEARCHERS BEGAN MAPPING THE BODY'S IMMUNE RESPONSE TO THE TUBERCULOSIS BACTERIA, MARKING THE FIRST TIME THIS MASSIVE EFFORT HAS EVER BEEN UNDERTAKEN BY ILLUMINATING PREVIOUSLY UNKNOWN CELLULAR PLAYERS IN THE BODY'S TUBERCULOSIS DEFENSE, INSTITUTE RESEARCHERS HOPE TO FIND IMPORTANT CANDIDATES FOR DEVELOPING A NEW AND BETTER VACCINE LA JOLLA INSTITUTE RESEARCHERS ARE ALSO WORKING TOWARD THE CREATION OF FIRST-EVER VACCINES FOR MALARIA AND DENGUE VIRUS IN ADDITION TO THEIR RESEARCH ACTIVITIES IN 2010, INSTITUTE SCIENTISTS ALSO LECTURED AT MEDICAL RESEARCH SEMINARS THROUGHOUT THE WORLD AND ORGANIZED NUMEROUS SCIENTIFIC CONFERENCES WHILE IT IS DIFFICULT TO DETERMINE THE NUMBER OF PERSONS BENEFITED BECAUSE OF THE BROAD APPLICABILITY OF THE LA JOLLA INSTITUTE'S FINDINGS AND
