Corrective Surgery Program provided free cataract surgeries for 1,113 elderly patients in rural areas of the Mekong delta region in southern Vietnam (\$40,057), orthopedic surgeries and equipment for 530 children in 14 provinces in Vietnam (\$120,098), and cleft palate surgeries for 47 children in Khanh Hoa province (\$4,213).

Mobile Health Care Program organized a group of 70 doctors, dentists, pharmacists, nurses, and support volunteers to provide free medical and vision check-ups, and dental extractions for 3,172 children and elderly patients in Bac Binh district, Binh Thuan province. Patients received free one week supplies of medicine, reading glasses, and gifts.
