World Orphans' belief is that the best place for a child is in a family - ideally the birth family - but extended family, foster care or a church-based children's home are all solutions that allow the child to remain immersed within their community. World Orphans' indigenous church partners work within a model of orphan care we call the Continuum of Care that seeks to provide for the needs of the whole child - physical, mental, emotional and spiritual. This is primarily accomplished through the establishment of indigenous church-based orphan prevention, residential, and self-sustainability programs. Examples of programs include home based care, church based foster care programs, and secondary educational support. During the period 1/1/2010 - 12/31/2010, World Orphans helped to fund 62 projects in 12 countries for the support of orphans. It is estimated that 4,008 children were impacted through World Orphans' programs during this period.
