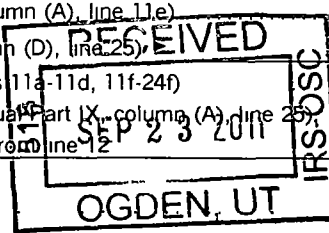

Since inception the organization has provided more than 27,000 computers to San Diego  
charitable organizations and individuals. These consist of donated equipment that has  
been refurbished and updated. In 2010 the organization gave 1675 computers to other  
non-profits organizations and 1639 computers to individuals. The estimated value of  
these donations for 2010 was \$544,867. The value of the hardware received in 2010 by  
San Diego Futures Foundation that was able to be refurbished was \$677,100.
