Provided 32 water projects within the Trichy District of Tamil Nadu along with funding after school programs, health education worker for 5 villages, along with funding for income generating activities involving goats, cows and agriculture seed. Estimated impact of 18,000 people. Further supported the efforts at Annai Erica School and Orphanage with funding for food, books, teachers, utilities and other necessary expenses for their continued operation thereby positively impacting over 1,000 school age children. This work was carried out through our partner Depressed People's Welfare Association. Additionally, organized teams of donors and volunteers to travel to project sites for visual inspection and dedication of each drilled water project.

4b (Code:) (Expenses \$ 107,315.00 including grants of \$ 83,795.00) (Revenue \$ 18,750.00)
Provided 32 water projects within Andhra Pradesh along with a sanitation project thereby positively impacting the lives of approximately 18,000 people. Also, provided financial assistance for a micro-enterprise solution in the East Godavari District and funds for those suffering from HIV/Aids and leprosy; thus generating an impact towards 750 men, women and children. Ongoing assistance to New Life Home in Chintalapudi where 45 orphan children reside; financial assistance helps with their food, clothing, education and shelter. This work was carried out through our partner, Nazareth Association for Social Awareness. Additionally, organized teams of donors and volunteers to travel to project sites for visual inspection and dedication of each drilled water project. In addition to site visits, the teams focused on spreading goodwill towards the recipients of each project along with those benefiting from our other program services such as assistance to those suffering from HIV/Aids, leprosy and children who are considered orphaned or semi-orphaned.

4c (Code:) (Expenses \$ 8,400.00 including grants of \$ 8,400.00) (Revenue \$ 0)
Further assisted in the development of New Life Children's Home in which is a school/orphanage for 165 orphan and semi-orphan children. Support includes the building of a boundary wall, an additional source for water, cows for milk and to help with ongoing operational expenses necessary for feeding, clothing and educating the children. This work was carried out through our partner, Society for Helpless and Economically Backward Areas.
