Legacy Charities is involved in facilitating programs that bring orphaned infants, toddlers, young children with medical needs, and blind children into foster care Legacy Chanties facilitates care for the orphans in appropriate facilities, arranges medical care and surgical procedures as needed The organization is also involved in community development, providing assistance to the poor, assisting volunteers in medical clinics, and sending relief and charity workers to establish new projects in western and other remote areas in China Legacy Chanties is currently focused on China, but the work is not limited to China Legacy Charities worked on several major projects in 2010 New Day Foster Home 23 children were adopted, 21 surgeries were provided Additional Programs Beijing Home This is a home for long term care Children arrive there in need of surgery, and following surgery, they are placed with a foster family, if their health permits The children remain at the Beijing Home until they are adopted Beijing Foster Program This is a foster parent program for children waiting to be adopted Beijing Healing Home (begun Spring 2008) An extension of New Day Foster Home, children in need of medical care are brought from orphanages in other parts of China and remain until they receive the care they need Hohhot Foster Care Program, Hohot & Jingdezhen program, and Luoyang programs Legacy Charities is partnered with the government to arrange for care and physical therapy for the children in these orphanages Legacy provides a formula program for these and an additional orphanage to feed children one year old and younger New Day South A duplication of our original orphanage project in Beijing, another orphanage was opened in Southern China in 2010 There are currently six children in the New Day South Foster Home Forever Home A program for children who reach the age of being "unadoptable", where they can live in a family atmosphere, attend school, and be prepared to enter society
