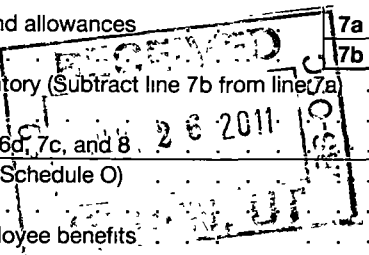

In Israel, the entire family helped to run a soup kitchen which ministered to 150 people a week. With this outreach a chess club for the Russians was begun averaging around 10 people a week and at least one sermon a week was preached by the Martin family. A youth basketball outreach program was started in Tel-Aviv with around 20 young people participating. A church was begun in Tel-Aviv Israel averaging 50 people a week. A weekly bible study was begun with average attendance of 15 people. A men's Bible Study was begun with 5 men in attendance and a women's Bible Study was begun with 7 women in attendance. A college & career group with 10-15 young adults was begun. There were 2 salvations in Israel due to the outreaches of the church that was begun in Tel-Aviv.
