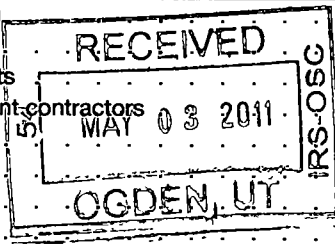

The Christensen Fund provided funding for the following program: Sidama Sustenance, Shelter and Senior Spirit.

This proposal seeks to honor Sidama foodways, which includes food production, exchange, distribution, and consumption patterns, in the food landscape of Ethiopia's Rift Valley. It seeks to consolidate Sidama cultural identity and local agro-biodiversity through

- a) encouraging local gardening techniques, publishing a cookbook and serving Sidama meals;
- b) facilitating traditional Sidama builders to become the stewards of local architecture by owning a governance structure to spread and perpetuate this particular knowledge;
- c) revitalizing the spirit of the seniors by organizing councils, ceremonies and documenting histories

The budget requested is \$50,000 over two years. This first year \$24,350 was allocated and \$ 23,608 was spent on the following activities:

- 1) Planted a traditional demonstration Sidama garden to grow vegetables for the school lunch program
- 2) Served Sidama meals at Sidama cultural events and hosted 4 cultural events
- 3) Compiled Sidama recipes for the publication of a Sidama Cookbook
- 4) Incorporated the traditional bamboo weavers who build Sidama huts
- 5) Formed a Senior Council made up of Sidama elders. Provide meeting place and meals. Seniors transmit cultural heritage through story-telling to the youth

Other Changes in fund balances: \$1607.36 Additional personal contributions made for daily operations by principal organization directors and \$1000 in petty cash. Total is \$2,607/36
