Women and Childrens Shelter The Women and Childrens Shelter provides immediate, temporary solutions to those who find themselves homeless due to domestic violence, poverty, and other circumstances beyond their control In a safe and welcoming environment, case management is provided to women and their families to begin to address the issues surrounding the circumstances that led to their homelessness to help develop more permanent solutions In 2010, 11,652 nights of lodging and 30,878 meals were provided to women and their families along with transitional services to provide more permanent solutions
