We are a food pantry. 2010 we fed 42515 people. Means tested clients receive a 3 day supply of food once a month. We also organize Mobile Food Pantries in collaboration with the West Ohio Food Bank and host organizations. We organized 21 Mobile Pantries in 2010. No cash is given. Gift certificates for a local super market chain are given out as part of Christmas baskets. We also give out vouchers for milk from the local supermarket when UHT boxed milk is not available.

4b (Code:) (Expenses \$ 5726.12 including grants of \$ \$375.00) (Revenue \$ 0)
We receive donated clothing, some new mostly used. We also purchase a limited amount of clothing-underware & socks. The clothing is sorted by volunteers and placed on display in a store like atmosphere. Means tested clients are allowed to take clothing twice a month. Clothing in excess of our needs is given to the St Vincent de Paul Society for transportation to the needy in southern Ohio. We supplied clothing to 28361 individuals in 2010. No Cash is given.

Taxable items such as soap, paper goods and school supplies are purchased by Chopin and given to needy clients. We served 24,724 individuals with these items in 2010. No cash is given.
