Almost every part of this Form 990 was amended to reflect accurate information. Key amendments included:

1. Form 990, Part IX - Reflects more reasonable functional expense allocations. Previously, all expenses were reported as program service expenses.
2. Corrects accounting errors discovered which resulted in cash being overstated by \$12,800, grant expenses being understated by \$12,000, and accounting fees being understated by \$800.
3. As a result of this amendment, the contact information, principal officer, etc. are amended to reflect the information as of filing.
4. Schedules A, B, F, I, and O are updated and amended to provide appropriate information. Previously, Schedules F and I were not filed.
5. The list of directors and officers is corrected to include all such individuals, hours, and compensation.
6. Revenues and expenses have been reclassified and reported on more appropriate lines in Form 990, Parts VIII and IX.
