Form 990, Part VI, Section A, Line 3 - The organization agreed in June, 2010 to turn over payroll functions to an independent payroll management company, Payroll Management, Inc., primarily because insurance costs were greatly reduced by using such a firm.

Form 990, Part VI, Section B, Line 11a - The Form 990 is prepared by the Executive Director and organization's bookkeeper, reviewed by the treasurer, and presented to the Board of Directors prior to submittal to the Internal Revenue Service.

Form 990, Part VI, Section B, Line 12c - Any financial actions taken on behalf of the organization, notably distribution of grant funds to member agencies within the Continuum of Care, are first handled through a request for proposal, evaluation by an independent and impartial review committee, with recommendations sent to the Board of Directors. Any director with an interest in the outcome of grant distribution, i.e. is a member of a church which has applied for funding, is asked to remove himself or herself from both the discussions and vote on actions taken by the Board on this matter. Funding is provided for direct services only, and may not be used to compensate any officers or key employees of any organization, including members of the Board of Directors for Okaloosa Walton Homeless Continuum of Care/ Opportunity, Inc. Receipts are reviewed by an independent auditor to ensure compliance with this policy.

Form 990, Part VI, Section B, Line 15 - A committee of the Board of Directors undertook a salary review for the Executive Director, which included receiving comparables from other similar organizations. Although the salary review indicated that the Executive Director is being paid at levels far below those of comparable organizations, the full Board of Directors determined that the organization does not have adequate discretionary (non-grant) funding to sustain compensation beyond what is currently provided.
