Madison Public Library is a publicly funded community resource offering lifelong learning and enrichment opportunities to people from cradle to grave, focussing on residents of the state of Ohio. Resources include informational and cultural materials, computers and Internet access, programs, classes and displays. Staff develop collections and programs to meet user needs and requests and assist users in locating and utilizing information.

Primary: Provide materials in a variety of formats (print, AV, electronic) for patrons to use in the library or at home to enrich their lives. Materials range from very simple for young children to complex, higher level information for advanced students and adults. Materials are borrowed to learn new skills or explore an area of interest. We are currently focussing on materials related to job searching and pursuing new careers.

The majority of library staff and activities are devoted to this service. In 2010, the library circulated 552,857 items and accessed information online over 70,000 times. Over 16,500 items were delivered to homebound patrons.

Another major line of business revolves around providing assistance for information seekers, including a place to do their work and computers and Internet access. Library hours were expanded in the 4th quarter of 2010 (with no increase in staffing or funding) The number of people in the building has expanded rapidly since then In 2010, over 155,000 patrons used the library and over 33,000 reference questions were answered by staff. Approximately 38, 500 used the library's computers, while many more took advantage of the Wi-Fi access with their own computers.

Significant resources are devoted to providing programs and classes to all ages of our public. These range from babytime and toddler story times to programs on understanding and choosing Medicare supplements. On occasion, speakers are hired, but programs are primarily prepared and presented by staff members and volunteers. other costs include advertising, overhead and maintenance costs and office supplies related to or used in the program In 2010, 633 programs were held in the library or presented by library staff with 11,551 attendees
