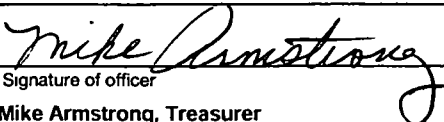

Johnson Memorial Hospital Guild High School Scholarship

Instructions

OBJECTIVE: To financially assist **two** senior high school students or high school graduate within last two years, who plan to continue their education in a health related field at any recognized and accredited school in Indiana.

SCHOLARSHIP AWARD: The Johnson Memorial Hospital Guild will provide a partial scholarship grant to any student who best fulfills the qualifications as set forth by the Scholarship Committee. This scholarship grant will be \$2,500 for the year 2009-2010 school year. If a recipient does not finish the training program, he/she will be expected to repay the amount granted on terms agreed to by the Scholarship Committee and recipient. The amount will be paid directly to the school upon proof of acceptance by the school.

In awarding a scholarship to students, the Hospital Guild is interested in showing its support for continuing education, while at the same time showing its desire to support our local hospital. It is the hope of the Hospital Guild that the recipients will return to Johnson Memorial Hospital for employment at the completion of his/her studies.

ELIGIBILITY: The recipients must be current high school seniors or graduates in one of the following categories:

- A) JMH teen volunteer (whether from a Johnson County school or not), or
- B) Child of JMH employee (whether from a Johnson County school or not).
- C) Recent (within the last two years) graduates/seniors from a Johnson County high school

BASIS OF AWARDING SCHOLARSHIP: The scholarship will be awarded based on the student's past academic performance (B average or above), leadership skills, citizenship, and financial need.

FORM OF APPLICATION: The Hospital Guild furnishes a form, entitled "Memorandum of Facts" which must be completed and will be part of the application. It is preferred that each applicant use their own ingenuity in presenting their case in an orderly, concise and chronological manner.

In addition to the "Memorandum of Facts," we require:

1. A statement of approximately 300 words prepared by the Applicant summarizing activities and accomplishments which qualify you for the scholarship. Also, please include your educational and career goals.
2. A complete transcript of the applicant's high school record, signed by the proper school officials. The transcript should list the courses taken, the grades received and the rank of the applicant in the class.
3. A letter of recommendation from a school authority that covers information concerning the applicant's character, personality and leadership skills.
4. Two letters of endorsement from responsible people, **not related to the applicant**, who can attest to the applicant's character, integrity, values, and willingness to work and study.

**The Scholarship Committee may personally interview applicants at the discretion of the Committee.*

FILING OF APPLICATION: The complete application must be sent to the Scholarship Committee of the Johnson Memorial Hospital Guild and postmarked by April 1, 2010. Applications that do not conform to the requirements will not be considered.
