The Taxpayer provides a variety of topical areas in which young people can participate in and develop leadership skills. These skills are developed through hands-on experience by allowing young adults to become leaders of their groups. The Taxpayer also provides a wide variety of workshops for young people to attend through Purdue University’s Cooperative Extension Service. In 2010, the Taxpayer had 26 last-year 4-H students participate in its Honor Group, which completed a service project benefiting the Johnson County Fair. The students chose the project, received approval from the Fair Board, secured funds and supplies, and finished the project in time for the annula fair in July. The project chosen by the Honor Group was to construct a shelter building and install additional picnic tables near. The Taxpayer also afforded other young people to attend workshops to deal effectively with people that have different personality types, seek out local grants for community service projects sponsored by the students churches, schools and other not-for-profit groups (such as the girl and boy scouts, FFA, etc), and leadership skill set building at Purdue University. The Taxpayer also supported the 1,064 local young people who participated in projects judged at the local fair.
