Granting Program The DeKalb County Community Foundation, Inc. is primarily an asset builder and grant maker. Its granting programs purpose is to improve the quality of life in DeKalb County, Indiana. Funds are granted out of the income earned by various charitable endowment funds held by the Foundation to various nonprofit organizations that service DeKalb County. The Foundation also grants from several nonpermanent funds to various nonprofit organizations that serve DeKalb County. In 2010 over 190 grants were awarded. See Schedule I, Part II and Part III, of this Form 990 for more information.

Scholarship Program Scholarship granting is a large program of the DeKalb County Community Foundation. In 2010, high school seniors from DeKalb County received scholarship grants from various scholarship funds held by the Foundation for college education. See Schedule I, Part III of this Form 990 for more information.

DeKalb County HOPE Helping Our Pupils Excel began as a literacy volunteer project to help elementary school children become proficient readers. Community leaders saw an unmet need in the DeKalb County schools as many students were entering schools with needs that went beyond what the traditional classrooms could provide. Today, HOPE trains adult volunteers as tutors/mentors and matches each adult with a child who has been identified by school personnel or a parent as able to benefit by having another caring adult in his/her life. Meeting in the schools once a week for an hour, volunteer and student pairs work one-on-one providing a friendship and helping children improve their reading, writing and basic math skills. The 2010 program has 95 volunteers matched with 115 students in three public school districts and two private schools. DeKalb County HOPE formed a board of directors in 2009, incorporated in the state of Indiana, and in 2010 gained 501(c)(3) non-profit status. Need is currently estimated at 1,200 students.
