This event brings together many agencies and programs that encourage quality development and positive growth in children.

Ivy Tech Community College, 4475 Central Avenue, Columbus, IN 47203 – \$1,200.00

A grant was awarded to the Ivy Tech Community College programs in Agriculture to finish the demonstration/educational garden to provide students with the opportunity to have an on-site space to learn and practice pest and disease identification and control, proper harvesting, rotational planting and soil sampling among other important agronomic, horticultural and landscaping skills.
