**FIRST AMENDED AND RESTATED  
ARTICLES OF INCORPORATION  
OF  
M. B. MOORE FOUNDATION, INC.**

M.B. Moore Foundation, Inc. ("Corporation"), having accepted the provisions of the Indiana Nonprofit Corporation Act of 1991, as amended ("Act"), hereby sets forth its First Amended and Restated Articles of Incorporation ("Articles of Incorporation") as follows:

**ARTICLE I**

**Name**

The name of the Corporation shall be M.B. Moore Foundation, Inc.

**ARTICLE II**

**Type of Corporation**

The Corporation is a nonprofit, public benefit corporation.

**ARTICLE III**

**Members**

**Section 1. Classes of Members.** There shall be two (2) classes of members (as the context shall require, hereinafter referred to as either "Member" or "Members") of the Corporation, namely, Class A and Class B.

(a) **Class A Members.** The Class A Member(s) shall have the exclusive right to vote on all matters of the types which are to be presented to members of corporations under the Act, including the right to vote for the election of directors and any additional rights to vote contained in these Articles of Incorporation or in the First Amended and Restated By-Laws of the Corporation ("By-Laws"). As of the filing of these Articles of Incorporation with the Indiana Secretary of State, there shall be two (2) Class A Members of the Corporation who are Mark B. Moore and Colleen Burch Moore. The By-Laws may contain provisions to create other Class A Memberships.

(b) **Class B Members.** The Class B Members shall consist of the members of the Board of Directors. The Class B Members shall have no rights or obligations whatsoever during any period in which the Corporation has at least one (1) Class A Member. During any period in which the Corporation has no Class A Members, the Class B Members shall have all rights and obligations which Class A Members would otherwise have, including the right to vote, but only until such time, if any, at which there are again one (1) or more Class A Members, at which time the Class B Members will again have no rights or obligations whatsoever.

**Section 2. Transferability of Memberships; Termination of Memberships.** Except as set forth herein or the Corporation's By-Laws, memberships shall not be transferrable in any manner whatsoever. Upon the death, the incompetency (as adjudicated by a court of competent jurisdiction) or the resignation of a member, all membership rights, privileges and duties of such member shall immediately terminate, without necessity of any action by the Corporation. The termination due to death or any other reason of a Class A Member shall be treated according to Article XI, Section 2 of the Corporation's By-Laws.

**ARTICLE IV**  
**Purposes, Powers and Prohibited Activities**

**Section 1. Purposes.**

(a) The Corporation is a not-for-profit corporation, and the purposes for which the Corporation is organized, and for the accomplishment of which it shall be exclusively operated, are the promotion and support of religious, educational or charitable purposes, or all of them. Without in any way limiting the generality of the foregoing, but by way of amplification, definition and illustration of the above phrase "the promotion and support of religious, educational or charitable purposes," it is hereby stated that such purposes shall include the following:

(i) The promotion of religion, including, but not limited to, the donation of aid and support to or for the use and benefit of religious institutions, organizations, trusts, funds, and corporations.

(ii) The promotion of education generally, including, but not limited to, the donation of aid and support to or for the use and benefit of institutions, organizations, trusts, funds, and corporations engaged in literary, artistic, scholarly and scientific pursuits and in research of any character incident thereto.

(iii) The promotion of charitable purposes generally, including, but not limited to, the donation of aid and support to or for the use and benefit of individuals, institutions, organizations, trusts, funds, and corporations organized or operated for, or engaged in, charitable pursuits and work of any character and the donation of aid and support to or for the use and benefit of any public object or purpose.

Such religious, educational and charitable purposes aforesaid, and the character of the institutions, organizations, trusts, funds, and corporations, shall be such as are recognized as exempt from federal taxation as described in Section 501(c)(3) and Section 2522(a)(2) of the Internal Revenue Code of 1986, as amended, (hereinafter referred to as the "Code") and the Treasury Regulations promulgated thereunder, so that contributions to the Corporation will be deductible under Section 170(c), of the Code and which are described in Sections 2055(a), 2522 and 2106(a)(2) of the Code. For the purposes of these Articles of Incorporation, all references to Sections of the Code shall be deemed to

include reference to the corresponding provisions of any future United States internal revenue law and the Treasury Regulations promulgated thereunder.

(b) In furtherance of the aforesaid purposes, the Corporation may transact any and all lawful business permitted under the Act.

**Section 2. Powers.** Except as otherwise provided in these Articles of Incorporation, the Corporation shall have, hold, enjoy and exercise any and all rights, privileges and powers vested in or conferred upon a corporation organized under the Act.

**Section 3. Prohibited Activities.**

(a) No part of the Corporation's income, corpus or principal assets shall ever inure to the benefit of, or be distributable to, directly or indirectly, any private individual, and no Director or officer of the Corporation may or shall receive any pecuniary benefit from the same; provided, however, that private individuals may be paid such reasonable compensation for services actually rendered and that are necessary to organize the Corporation and to carry out the purposes of the Corporation, as may be fixed in the manner provided by the Board of Directors. No individual shall be precluded from taking such employment and reasonable compensation by reason of the fact that he or she is a Director or officer of the Corporation.

(b) The Corporation shall not in any manner or to any extent participate in, or intervene in (including the publishing or distributing of statements), any political campaign on behalf of (or in opposition to) any candidate for public office, nor shall a substantial part of its activities consist of carrying on propaganda or otherwise attempting to influence legislation or any political campaign on behalf of (or in opposition to) any candidate for public office.

(c) The Corporation shall not accept gifts or other contributions if the use or expenditure of the gift or contribution is subject to any condition which is inconsistent with the purposes of the Corporation as set forth in Section 1 of this Article IV.

(d) The Corporation shall not conduct or carry on any activities prohibited from being conducted or carried on by an organization exempt from Federal income tax under Section 501(c)(3) of the Code, and the Regulations promulgated thereunder, or by a Corporation, contributions to which are deductible under Section 170(c)(2), and which also are described in Section 2055(a)(2), Section 2522 and Section 2106(a)(2) of the Code.

(e) The Corporation shall make no advancements for services to be performed in the future, nor shall the Corporation make any loan of money or property, to any Director or officer of the Corporation, other than advances of expenses in connection with a possible indemnification matter.

(f) Notwithstanding any other provisions of these Articles of Incorporation, the Act, or any other law, rule or regulation, the Corporation shall:

(i) Distribute during each taxable year amounts sufficient to avoid liability for the tax imposed by Section 4942 of the Code.

(ii) Not engage in any act of self-dealing as defined in Section 4941(d) of the Code.

(iii) Not retain any excess business holdings as defined in Section 4943(c) of the Code.

(iv) Not make any investment in such manner as to subject the Corporation to tax under Section 4944 of the Code.

(v) Not make any taxable expenditure as defined in Section 4945(d) of the Code.

#### **ARTICLE V**

##### **Registered Agent, Registered Office and Principal Office**

**Section 1. Registered Agent; Registered Office.** The name and street address of the Registered Agent and the Registered Office of the Corporation is Matthew S. Carr, Krieg DeVault, LLP, One Indiana Square, Suite 2800, Indianapolis, Indiana 46204-2017.

**Section 2. Principal Office.** The post office address of the principal office of the Corporation is 9771 Roxbury Drive, Fishers, Indiana 46038.

#### **ARTICLE VI**

##### **Dissolution; Distribution of Assets on Dissolution or Final Liquidation**

Except as otherwise may be provided in the By-Laws, upon the dissolution of the Corporation, and after payment, or provision is made for the payment, of all liabilities and debts of the Corporation, the remaining assets of the Corporation shall be distributed to an organization or organizations which are, at the time of such distribution, organized and operated exclusively for public, charitable, religious, scientific, testing for public safety, literary or educational purposes, which purposes then qualify it or them for exemption from Federal income tax under the provisions of Section 501(c)(3) of the Code and as then qualify contributions to it or them for deduction under Section 170(c), Section 2055(a)(2), Section 2522 and Section 2106(a)(2) of the Code, in accordance with any provisions regarding dissolution set forth in the By-Laws.

**ARTICLE VII**  
**Provisions for Regulation and Conduct**  
**of the Affairs of Corporation**

In addition to the By-Laws and consistent with the Act, the following provisions for the regulation and conduct of the affairs of the Corporation, and for the creation, definition, limitation or regulation of the powers of the Corporation and its Directors, shall apply:

**Section 1. Amendment of Articles of Incorporation.** The Corporation reserves the right to amend, alter, change or repeal any provisions contained in these Articles of Incorporation or in any amendment hereto in accordance with the provisions of the Act; provided, however, that such right shall not authorize any amendment which would have the effect of disqualifying the Corporation as a tax-exempt organization under Section 501(c)(3) of the Code or would have the effect of disqualifying contributions to the Corporation for deduction under Section 170(c)(2), Section 2055(a)(2), Section 2522 or Section 2106(a)(2) of the Code.

**Section 2. Adoption and Amendment of By-Laws.** The power to make, alter, amend or repeal any provisions contained in the By-Laws of the Corporation is vested solely in the Class A Member(s) of the Corporation entitled to vote thereon, and the Board of Directors shall have no such power; provided, however, that such power shall not authorize any amendment, alteration or change which would have the effect of disqualifying the Corporation as a tax-exempt organization under Section 501(c)(3) of the Code or would have the effect of disqualifying contributions to the Corporation for deduction under Section 170(c)(2), Section 2055(a)(2), Section 2522 or Section 2106(a)(2) of the Code.


**Section 3. Intention that Corporation Qualify for Exemption from Federal Income, Gift and Estate Taxes.** The Corporation intends that it shall qualify as a tax-exempt organization under Section 501(c)(3) of the Code and that contributions to the Corporation shall qualify for deduction from Federal income, estate and gift taxes under Section 170(c)(2), Section 2055(a)(2) and Section 2522(a) of the Code, respectively, and all questions applicable to the Corporation shall be resolved accordingly, notwithstanding any provision in these Articles of Incorporation that might be construed as having the effect of compromising this objective. The powers and discretions of the Board of Directors or the officers with respect to administration of the Corporation shall not be exercised or exercisable except in a manner consistent with the Corporation's intent as expressed in this Section 3. To the extent that any other provision of these Articles of Incorporation or the By-Laws conflicts with the Corporation's primary intent as expressed in this Section 3 or gives rise to an ambiguity, such conflict or ambiguity shall be resolved as directed in this Section 3. Likewise, should there be an ambiguity as to whether any provision necessary for qualification of the Corporation as a tax exempt organization or for qualification of contributions to the Corporation for deduction from Federal income, estate and gift tax is included in these Articles of Incorporation, the ambiguity shall be resolved as directed in this Section 3.

**Section 4. Officers.** The Class A Members then entitled to vote shall have the exclusive authority to elect and remove the officers of the Corporation.

**FIRST AMENDED AND RESTATED  
BY-LAWS  
OF  
M.B. MOORE FOUNDATION, INC.**

**ARTICLE I  
Name, Office and Agent**

**Section 1. Name.** The name of the corporation is M.B. Moore Foundation, Inc. ("Corporation").

**Section 2. Registered Office and Registered Agent.** The post-office address of the Registered Office of the Corporation is One Indiana Square, Suite 2800, Indianapolis, Indiana 46204, and the name and post-office address of its Registered Agent in charge of such office is Matthew S. Carr, Krieg DeVault, LLP, One Indiana Square, Suite 2800, Indianapolis, Indiana 46204.

**ARTICLE II  
Fiscal Year**

The fiscal year of the Corporation shall begin each year on the first day of January and end on the last day of December of each year.

**ARTICLE III  
Members**

**Section 1. Classes of Members.** There shall be two (2) classes of members (as the context shall require, hereinafter referred to as either "Member" or "Members" of the Corporation, namely, Class A and Class B.

**Section 2. Class A Members.** There shall be two (2) Class A Members of the Corporation, namely, Mark B. Moore and Colleen Burch Moore, who shall have the exclusive right to vote as described in the Articles of Incorporation.

**Section 3. Class B Members.** The Class B Members shall consist of the members of the Board of Directors. The Class B Members shall have no rights or obligations whatsoever except during any period in which there are no Class A Members, as described in the Articles of Incorporation.

**ARTICLE IV  
Meetings of the Class A Members**

**Section 1. Place of Meeting.** Meetings of Class A. Members of the Corporation shall be held at such place, within or outside the State of Indiana, as may from time to time be designated by the President, or as may be specified in the notices or waivers of notice of such meetings.

**Section 2. Annual Meeting.** The annual meeting of Class A Members entitled to vote for the election of directors, and for the transaction of such other business as may properly come before the meeting, shall be held on the 3rd Tuesday in May of each year at such time and place as the President shall determine. Failure to hold the annual meeting during such month shall not work any forfeiture or a dissolution of the Corporation and shall not affect otherwise valid corporate acts. Such annual meeting shall be held at the same time and place, and in conjunction with, the annual meeting of the Board of Directors.

**Section 3. Special Meetings.** Special meetings of the Class A Members for any purpose or purposes, unless otherwise prescribed by the Indiana Nonprofit Corporation Act of 1991, as amended (the "Act") or by the Articles of Incorporation, may be called by the President, by a majority of the Class A Members entitled to vote at such meeting or by a majority of the Board of Directors.

**Section 4. Notice of Meetings.** A written or printed notice, stating the place, day and hour of the meeting, and in case of a special meeting, or when required by any other provision of the Act, or the Articles of Incorporation, or these By-Laws, the purpose or purposes for which the meeting is called, shall be delivered or mailed by the Secretary, or by the officer or persons calling the meeting, to the Class A Members of record entitled to vote at such meeting at least ten (10) days before the date of the meeting. Notice of any such meeting may be waived in writing by the Class A Members, and attendance at any meeting in person shall constitute a waiver of notice of such meeting. Notwithstanding the foregoing, unless otherwise required by the Act, no notice shall be required for the annual meeting of the Class A Members.

## **ARTICLE V** **Board of Directors**

### **Section 1. Number, Election and Term of Office.**

(a) The number of directors of the Corporation shall be four (4) unless changed by amendment of this Section 1(a).

(b) The term of office of each director shall be for a period of one (1) year and until his or her successor is duly elected and qualified. Directors shall be elected at the annual meeting of the Class A Members, or, if not so elected, at a special meeting of the Class A Members called for that purpose.

(c) In the event of an increase in the number of directors by amendment of these By-Laws, the election of the additional director or directors shall be by a vote of the Class A Members of the Corporation. No decrease in the number of directors shall have the effect of shortening the term of any incumbent director.

**Section 2. Vacancies.** Any vacancy occurring on the Board of Directors caused by resignation, death or otherwise shall be filled until the next annual meeting only through a vote of the Class A Members of the Corporation who are entitled to vote to fill such vacancy on the Board of Directors. If the vacancy is being filled through a vote of the Class B Members, the Class B Members shall give due consideration to any recommendation regarding the individual who should be elected to fill such vacancy as may have been previously expressed by the Class A Members in a resolution or resolutions adopted by the Class A Members. It is the intent of the Corporation that such recommendation be followed unless (a) the individual so recommended is unable or unwilling to serve, or (b) such individual's service on the Board of Directors, in the reasonable business judgment of the Class B Members, would be detrimental to the Corporation.

**Section 3. Annual Meeting.** The annual meeting of the Board of Directors shall be held at the same time and place and in conjunction with the annual meeting of the Class A Members.

**Section 4. Regular Meeting.** In addition to the annual meeting of the Board of Directors, a regular meeting of the Board of Directors shall be held on the 3<sup>rd</sup> Tuesday in May of each year (or on such other date in the month of May as the President may determine) at such time and place as the President shall determine and cause to be communicated to the directors by the Secretary at least forty-eight (48) hours prior to the time of the meeting. Such regular meeting of the Board of Directors may be held without further notice or upon such notice as may be fixed by the directors. Regular meetings may be held either within or outside the State of Indiana.

**Section 5. Special Meetings.** Special meetings of the Board of Directors may be called by the President or any two directors. Notice of the time and place, either within or outside the State of Indiana, of a special meeting shall be served upon or telephoned to each director at least twenty-four hours, or sent by U.S. Mail, facsimile or by other electronic communication to each director at his or her usual place of business or residence at least forty-eight hours, prior to the time of the meeting. Directors, in lieu of such notice, may sign a written waiver of notice either before the time of the meeting, at the meeting or after the meeting. Attendance by a director in person at any such special meeting shall constitute a waiver of notice.

**Section 6. Quorum.** A majority of the actual number of directors elected and qualified from time to time shall be necessary to constitute a quorum for the transaction of any business. The act of a majority of the directors present at the meeting, at which a quorum is present, shall be the act of the Board of Directors, unless the act of a greater number is required by the Act, by the Articles of Incorporation or by these By-Laws. A director of the Corporation who is present at a meeting of the Board of Directors at which action on any corporate matter is taken shall be presumed to have assented to the action taken unless such director's dissent shall be entered in the minutes of the meeting or unless such director shall file a written dissent to such action with the Secretary of the meeting before adjournment thereof or shall forward such dissent by hand-delivery or by certified mail to the Secretary of the Corporation immediately after the adjournment of the meeting. Such right to dissent shall not apply to a director who voted in

favor of such action and did not change his or her vote prior to the time that the result of such vote was announced by the Chairman of such meeting.

**Section 7. Consent Action by Directors.** Any action required or permitted to be taken at any meeting of the Board of Directors or of any committee thereof may be taken without a meeting, if a written consent to such action is signed by all members of the Board of Directors or such committee, as the case may be, and such written consent is filed with the minutes of proceedings of the Board of Directors or committee. Action taken under this Section 7 is effective when the last director or committee member, as the case may be, signs the consent, unless the consent specifies a different prior or subsequent effective date.

**Section 8. Conference Telephone Meetings.** A director may participate in a meeting of the Board of Directors through the use of telephonic, video or other electronic means which allow all persons participating in the meeting to communicate with each other, and participation by these means constitutes presence in person at the meeting.

**Section 9. Committees.** The Board of Directors may designate such committees with such responsibilities and powers, in accordance with the Act, as the Board of Directors may specify. Members of such committees may, but need not, be directors of the Corporation.

## **ARTICLE VI** **Officers**

**Section 1. Principal Officers.** The principal officers of the Corporation shall be a President, a Vice President, a Treasurer and a Secretary. The Corporation may also have, at the discretion of the Board of Directors, such subordinate officers as may be appointed in accordance with the provisions of these By-Laws. Officers may, but need not, be members of the Board of Directors.

**Section 2. Election and Term of Office.** The principal officers of the Corporation shall be chosen annually by the Class A Members at the annual meeting of the Class A Members. Each such officer shall hold office for one (1) year and until his successor shall have been duly chosen and qualified, or until his death, or until he shall resign, or until he shall have been removed in the manner hereinafter provided.

**Section 3. Removal.** Any principal officer may be removed, with or without cause, at any time, by resolution adopted at a regular or special meeting of the Class A Members then entitled to vote.

**Section 4. Subordinate Officers.** In addition to the principal officers enumerated in Section 1 of this Article VI, the Corporation may have one or more Assistant Treasurers, one or more Assistant Secretaries and such other officers, agents and employees as the Board of Directors may deem necessary, each of whom shall hold office for such period, may be removed with or without cause, have such authority and perform such duties as the President or Board of Directors may from time to time determine. The Board of Directors may delegate to any

principal officer the power to appoint and to remove any such subordinate officers, agents or employees.

**Section 5. Resignations.** Any officer may resign at any time by giving written notice to the Board of Directors, the President or the Secretary. Any such resignation shall take effect upon receipt of such notice or at any later time specified therein, and, unless otherwise specified therein, no acceptance of such resignation shall be necessary to make it effective.

**Section 6. Vacancies.** Any vacancy in any office may be filled only by the Class A Members. The person elected to fill such vacancy shall serve until the next annual meeting of the Class A Members and until his or her successor shall have been duly chosen and qualified.

**Section 7. President.** The President shall preside at all meetings of the Class A Members and all meetings of directors. He shall be the chief executive officer of the Corporation and, as such, shall have general executive and supervisory authority over the Corporation's affairs, and other officers and employees of the Corporation. The President may enter into any contract or execute and deliver any instrument in the name and on behalf of the Corporation. The President is hereby appointed attorney-in-fact for and agent of the Corporation, and shall have full power and authority in the name and on behalf of the Corporation, to attend and to act at, and to vote all memberships, partnership interests, and all stock or other securities entitled to be voted at, any meetings of members or security holders of such corporations (whether for profit or nonprofit), partnerships, associations or entities in which the Corporation may hold memberships, partnership interests, or securities, in person or by proxy, as a member, partner, security holder or otherwise, and at such meetings shall possess and may exercise any and all rights and powers incident to the holding of such memberships, partnerships, or the ownership of such securities, and which as the holder or owner thereof, the Corporation might have possessed and exercised, if present, or to consent in writing to any action by any such other corporation, partnership, association or entity. In general, the President shall perform all duties and have all powers incident to the office of President, as herein defined, and all such other duties and powers as, from time to time, may be assigned to the President by the Class A Members.

**Section 8. Vice President.** The Vice President shall perform such duties and have such powers as the Board of Directors or the President may from time to time assign. In the event of any absence or disability of the President, the Vice President shall possess the authority and perform the duties of the President.

**Section 9. Treasurer.** The Treasurer shall have charge and custody of, and be responsible for, all funds and securities of the Corporation and shall deposit all such funds in the name of the Corporation in such banks or other depositories as shall be selected by the Board of Directors. The Treasurer shall prepare and maintain books of account and records regarding the financial affairs of the Corporation; shall upon request exhibit at all reasonable times the books of account and records to any of the directors of the Corporation during business hours at the office of the Corporation where such books and records shall be kept; shall render upon request by the Board of Directors a statement of the condition of the finances of the Corporation at any meeting of the Board of Directors or at the annual meeting of the members; shall receive, and

give receipt for, moneys due and payable to the Corporation from any source whatsoever; and in general, shall perform all duties as from time to time may be assigned by the President or the Board of Directors. The Treasurer shall give such bond, if any, for the faithful discharge of his or her duties as the Board of Directors may require.

**Section 10. Secretary.** The Secretary shall keep or cause to be kept in the books provided for that purpose the minutes of the meeting of the member(s) and of the Board of Directors; shall duly give and serve all notices required to be given in accordance with the provisions of these By-Laws and by the Act; shall be custodian of the records of the Corporation and attest to all documents, the execution of which on behalf of the Corporation under the Secretary's attestation is duly authorized in accordance with the provisions of these By-Laws; and, in general, shall perform all duties incident to the office of Secretary and such other duties as from time to time may be assigned by the President or the Board of Directors.

## **ARTICLE VII** **Contracts, Loans and Checks**

**Section 1. Contracts.** In connection with the authority granted to the President of the Corporation pursuant to Article VI, Section 7 of these By-Laws, the President may authorize any other officers, employees or agents of the Corporation to enter into any contract or execute and deliver any instrument in the name and on behalf of the Corporation. Such authorization may be general or limited to specific instances. No other officer, employee or agent of the Corporation shall have any power to bind the Corporation or to render it liable for any purpose or amount unless so authorized by the President or by these By-Laws.

**Section 2. Checks.** All checks, drafts or other orders for payment of money of the Corporation shall be signed by the President or any other officer to whom the President has delegated such authority from time to time.

## **ARTICLE VIII** **Indemnification**

**Section 1. Definitions.** For purposes of this Article, the following terms shall have the following meanings:

(a) "Liabilities" and "Expenses" shall mean monetary obligations incurred by or on behalf of a Member, director or officer in connection with the investigation, defense or appeal of a Proceeding or in satisfying a claim thereunder and shall include, but shall not be limited to, attorneys' fees and disbursements, amounts of judgments, fines or penalties, excise taxes assessed with respect to an employee benefit plan, and amounts paid in settlement by or on behalf of a Member, director or officer.

(b) "Other Enterprise" shall mean any corporation, partnership, limited liability company, limited liability partnership, joint venture, trust, employee benefit plan or other enterprise, whether for profit or not, for which a Member, director or officer is or

was serving, at the request of the Corporation, as a Member, director, officer, partner, manager, trustee, employee or agent.

(c) "Proceeding" shall mean any claim, action, suit or proceeding (whether brought by or in the right of the Corporation or Other Enterprise or otherwise), civil, criminal, administrative or investigative, whether formal or informal, and whether actual or threatened or in connection with an appeal relating thereto, in which a Member, director or officer may become involved, as a party or otherwise, (i) by reason of his being or having been a Member, director or officer of the Corporation (and, if applicable, an officer, employee or agent of the Corporation) or a Member, director, officer, partner, manager, trustee, employee or agent of an Other Enterprise or arising out of his status as such, or (ii) by reason of any past or future action taken or not taken by a Member, director or officer in any such capacity, whether or not he continues to be such at the time he incurs Liabilities and Expenses under the Proceeding.

(d) "Standard of Conduct" shall mean that a Member, director or officer, based on facts then known to the Member, director or officer, discharged the duties as a Member, director or officer, including duties as a Member of a committee, in good faith in what he reasonably believed to be in or not opposed to the best interests of the Corporation or Other Enterprise, as the case may be, and, in addition, in any criminal Proceeding had no reasonable cause to believe that his conduct was unlawful. The termination of any Proceeding, by judgment, order, settlement (whether with or without court approval) or conviction or upon a plea of guilty, shall not create a presumption that the Member, director or officer did not meet the Standard of Conduct. The termination of any Proceeding by a consent decree or upon a plea of nolo contendere, or its equivalent, shall create the presumption that the Member, director or officer met the Standard of Conduct.

**Section 2. Indemnification.** If a Member, director or officer is made a party to or threatened to be made a party to any Proceeding, the Corporation shall indemnify the Member, director or officer against Liabilities and Expenses incurred by him in connection with such Proceeding in the following circumstances:

(a) If a Member, director or officer has been wholly successful on the merits or otherwise with respect to any such Proceeding, he shall be entitled to indemnification for Liabilities and Expenses as a matter of right. If a Proceeding is terminated against the Member, director or officer by consent decree or upon a plea of nolo contendere, or its equivalent, the Member, director or officer shall not be deemed to have been "wholly successful" with respect to such Proceeding; or

(b) In all other situations, a Member, director or officer shall be entitled to indemnification for Liabilities and Expenses as a matter of right unless the Member, director or officer has breached or failed to perform his duties as a Member, director or officer in compliance with the Standard of Conduct and with respect to any action or failure to act by the Member, director or officer which is at issue in such Proceeding, such action or failure to act constituted willful misconduct or recklessness. To be entitled

to indemnification pursuant to this Section 2, the Member, director or officer must notify the Corporation of the commencement of the Proceeding in accordance with Section 5 and request indemnification. A review of the request for indemnification and the facts and circumstances underlying the Proceeding shall be made in accordance with one of the procedures described below; and the Member, director or officer shall be entitled to indemnification as a matter of right unless, in accordance with such procedure, it is determined beyond a reasonable doubt that the Member, director or officer breached or failed to perform the duties of the office in compliance with the Standard of Conduct, and the breach or failure to perform constituted willful misconduct or recklessness. Any one of the following procedures may be used to make the review and determination of a Member's, director's or officer's request for indemnification under this Section 2(b) or under Section 3:

(i) by the Board of Directors by a majority vote of a quorum consisting of directors who are not parties to, or who have been wholly successful with respect to, such Proceeding;

(ii) if a quorum cannot be obtained under (i) above, by a majority vote of a committee duly designated by the Board of Directors (in the designation of which, directors who are parties to such Proceeding may participate), consisting solely of two or more directors who are not parties to, or who have been wholly successful with respect to, such Proceeding;

(iii) by independent legal counsel selected by a majority vote of the full Board of Directors (in which selection, directors who are parties to such Proceeding may participate); or

(iv) by a committee consisting of three (3) or more disinterested persons selected by a majority vote of the full Board of Directors (in which selection, directors who are parties to such Proceeding may participate).

Any determination made in accordance with the above procedures shall be binding on the Corporation and the Member, director or officer.

(c) If several claims, issues or matters of action are involved, a Member, director or officer may be entitled to indemnification as to some matters even though he is not entitled to indemnification as to other matters.

(d) The indemnification herein provided shall be applicable to Proceedings made or commenced after the adoption of this Article, whether arising from acts or omissions to act which occurred before or after the adoption of this Article.

**Section 3. Prepaid Liabilities and Expenses.** The Liabilities and Expenses which are incurred or are payable by a Member, director or officer in connection with any Proceeding shall be paid by the Corporation in advance; provided, however, that the Member, director or officer shall first comply with the provisions of Indiana Code Section 23-17-16-10 for



reimbursements except that determinations and authorizations of payments may be made in accordance with the provisions under Section 2 of this Article VIII.

**Section 4. Exceptions to Indemnification.**

(a) Notwithstanding any other provisions of this Article to the contrary, the Corporation shall not indemnify a Member, director or officer:

(i) for any Liabilities and Expenses for which payment is actually made to or on behalf of a Member, director or officer under a valid and collectible insurance policy, except in respect of any excess beyond the amount of payment under such insurance; or

(ii) for any Liabilities or Expenses incurred in a suit or claim against the Member, director or officer arising out of or based upon actions attributable to the Member, director or officer in which the Member, director or officer gained any personal profit or advantage to which he was not legally entitled.

(b) Notwithstanding any other provisions of this Article to the contrary, the Corporation shall not be required to indemnify a Member, director or officer for any Liabilities and Expenses, to make prepayments of Liabilities and Expenses under Section 3 hereof, or to pay premiums for insurance described under Section 8 hereof to the extent that any such indemnification or payments may or will constitute an act of self-dealing under Section 4942 of the Internal Revenue Code of 1986, as amended, ("Code") and the Treasury Regulations promulgated thereunder or a taxable expenditure under Section 4941(d) of the Code and the Treasury Regulations promulgated thereunder; provided, however, that the Corporation may make such indemnification or payments if the Board of Directors (with respect to situations coming within the scope of Section 2(a) of this Article) or the Board of Directors and the appropriate person(s) described in Section 2(b)(i) through (iv) of this Article (with respect to situations coming within the scope of Section 2(b) of this Article) determine that it is in the best interest of the Corporation to do so; provided, further, that in no instance shall any indemnification or payment be made by the Corporation which would cause the Corporation to lose its status as an organization exempt from tax under Section 501(c)(3) of the Code. For the purposes of these By-Laws, all references to Sections of the Code shall be deemed to include reference to the corresponding provisions of any future United States internal revenue law and the Treasury Regulations promulgated thereunder.

**Section 5. Notification and Defense of Proceeding.** Promptly after receipt by a Member, director or officer of notice of the commencement of any Proceeding, the Member, director or officer will, if a request for indemnification in respect thereof is to be made against the Corporation under this Article, notify the Corporation of the commencement thereof; but the failure to so notify the Corporation will not relieve it from any obligation which it may have to the Member, director or officer under this Article or otherwise. With respect to any such Proceeding as to which the Member, director or officer notifies the Corporation of the commencement thereof:

(a) the Corporation will be entitled to participate therein at its own expense;  
and

(b) except as otherwise provided below, to the extent that it may so desire, the Corporation, jointly with any other indemnifying party similarly notified, will be entitled to assume the defense thereof, with counsel reasonably satisfactory to the Member, director or officer. After notice from the Corporation to the Member, director or officer of its election to assume the defense of the Member, director or officer in the Proceeding, the Corporation will not be liable to the Member, director or officer under this Article for any legal or other Expenses subsequently incurred by the Member, director or officer in connection with the defense thereof other than reasonable costs of investigation or as otherwise provided below. The Member, director or officer shall have the right to employ counsel in such Proceeding, but the Expenses of such counsel incurred after notice from the Corporation of its assumption of the defense thereof shall be at the expense of the Member, director or officer unless:

(i) the employment of counsel by the Member, director or officer has been authorized by the Corporation;

(ii) the Member, director or officer shall have reasonably concluded that there may be a conflict of interest between the Corporation and the Member, director or officer in the conduct of defense of such Proceeding; or

(iii) the Corporation shall not in fact have employed counsel to assume the defense of such Proceeding; in each of which cases the Expenses of counsel employed by the Member, director or officer shall be paid by the Corporation. The Corporation shall not be entitled to assume the defense of any Proceeding brought by the Corporation or as to which the Member, director or officer shall have made the conclusion provided for in (ii) above.

(c) The Corporation shall not be liable to indemnify a Member, director or officer under this Article for any amounts paid in settlement of any Proceeding without the Corporation's prior written consent. The Corporation shall not settle any action or claim in any manner which would impose any penalty or limitation on a Member, director or officer without the Member, director or officer's written consent. Neither the Corporation nor a Member, director or officer will unreasonably withhold consent to any proposed settlement.

**Section 6. Other Rights and Remedies.** The rights of indemnification provided under this Article are not exhaustive and shall be in addition to any rights to which a Member, director or officer may otherwise be entitled by contract or as a matter of law. Irrespective of the provisions of this Article, the Corporation may, at any time and from time to time, indemnify Members, directors, officers, employees and other persons to the full extent permitted by the provisions of the Act, or any successor law, as then in effect, whether with regard to past or future matters.

**Section 7. Continuation of Indemnity.** All obligations of the Corporation under this Article shall survive the termination of a Member's, director's or officer's service in any capacity or status covered by this Article.

**Section 8. Insurance.** The Corporation may purchase and maintain insurance on behalf of any Member, director, officer or other person or any person who is or was serving at the request of the Corporation as a Member, director, officer, partner, trustee or agent of an Other Enterprise against any liability asserted against such person and incurred by such person in any capacity or arising out of his status as such, whether or not the Corporation would have the power to indemnify such person against such liability under the provisions of applicable statutes, this Article or otherwise.

**Section 9. Benefit.** The provisions of this Article shall inure the benefit of each Member, director or officer and his respective heirs, personal representatives and assigns and the Corporation, its successors and assigns.

**Section 10. Severability.** In case any one or more of the provisions contained in this Article shall, for any reason, be held to be invalid, illegal or unenforceable in any respect, such invalidity, illegality or unenforceability shall not affect any other provision of this Article, but this Article shall be construed as if such invalid, illegal or unenforceable provision or provisions had never been contained herein.

## **ARTICLE IX** **Amendments**

The power to make, alter, amend or repeal these By-Laws is vested solely in the Class A Members of the Corporation entitled to vote thereon, subject to any approvals of third parties which may be required by the Articles of Incorporation. The Board of Directors shall have no power to make, alter, amend or repeal these By-Laws.

## **ARTICLE X** **Business Ethics; Conflicts of Interest**

**Section 1. Policies.** In furtherance of the Corporation's commitment to high standards of business ethics and integrity, the Corporation shall adopt those policies and procedures necessary to ensure that all business practices, grant-making activities and conflicts of interest procedures comply with all applicable laws and regulations and high ethical principles.

**Section 2. Annual Statement.** Upon initial appointment and annually thereafter, each director, officer and Corporation manager (as defined in Section 4946(b)(1) of the Code) ("Disqualified Person") shall sign a written statement which affirms that such person has received, read and understands the Corporation's business ethics and conflicts of interest policies and agrees to comply with all such policy requirements at all times.

**Section 3. Contracts or Transactions.** A contract or other transaction between the Corporation and a Disqualified Person or any other corporation, firm, association or entity in which a Disqualified Person is a director or an officer or is financially interested, may not be either void or voidable because of this relationship or interest or because the Disqualified Person of the Corporation that authorizes, approves or ratifies the contract or transaction if:

(a) The fact of the relationship or interest is disclosed or known to the Board of Directors or committee that authorizes, approves, or ratifies the contract or transaction by a vote or consent sufficient for the purpose without counting the votes or consents of the interested director;

(b) The contract or transaction is fair and reasonable to the Corporation; and

(c) The Corporation has received an opinion from its counsel to the effect that the contract or transaction will not give rise to an act of self-dealing, which is prohibited by Section 4941 of the Code.

**Section 4. Loans or Guarantees.** The Corporation may not lend money to or guarantee the obligation of a director or an officer of the Corporation.

## **ARTICLE XI**

### **Limits on Distributions**

**Section 1. General Limits.** The Corporation shall not make contributions in any one (1) fiscal year in excess of ten percent (10%) of the fair market value of the gross assets of the Corporation as of the end of the most recent previous fiscal year.

**Section 2. Special Distribution.**

(a) If the Class A Membership of Mark B. Moore terminates due to his death or any other reason, such termination shall not cause the dissolution of the Corporation, but rather the following shall apply: (i) one hundred percent (100%) of the Class A Membership held by Mark B. Moore shall be immediately transferred to his wife, Colleen Burch Moore, without further action, and (ii) Colleen Burch Moore shall immediately, and without further action, be appointed to replace Mark B. Moore in any director or officer capacity held by Mark B. Moore immediately prior to the termination. In the event that Colleen Burch Moore predeceases Mark B. Moore, upon the death of Mark B. Moore, the Class A Membership of Mark B. Moore shall be transferred according to subsection (c) below.

(b) If the Class A Membership of Colleen Burch Moore terminates due to her death or any other reason, such termination shall not cause the dissolution of the Corporation, but rather the following shall apply: (i) one hundred percent (100%) of the Class A Membership held by Colleen Burch Moore shall be immediately transferred to her husband, Mark B. Moore, without further action, and (ii) Mark B. Moore shall

immediately, and without further action, be appointed to replace Colleen Burch Moore in any director or officer capacity held by Colleen Burch Moore immediately prior to the termination. In the event that Mark B. Moore predeceases Colleen Burch Moore, upon the death of Colleen Burch Moore, the Class A Membership of Colleen Burch Moore shall be transferred according to subsection (c) below.

(c) If the Class A Membership of Colleen Burch Moore, if any, terminates due to her death or any other reason, such termination shall not cause the dissolution of the Corporation, but rather the following shall apply: (i) the Corporation shall make a one-time lump sum special grant to Moore Family Foundation, Inc. ("Moore Family Foundation"), an Indiana nonprofit corporation, of twenty-five percent (25%) of the fair market value of the gross assets of the Corporation determined as of the last day of the most recently ended fiscal year before the day on which the grant is made; provided, however, that Moore Family Foundation is then in existence and then qualifies as an organization exempt from Federal income tax under the provisions of Section 501(c)(3) of the Code, and as may qualify contributions to such organization for deduction under Section 170(c)(2), Section 2055(a)(2) and Section 2522 of the Code, (ii) the Corporation shall make a one-time lump sum special grant to The Matthew Frank Moore Foundation, Inc. ("Matthew Frank Moore Foundation"), an Indiana nonprofit corporation, of twenty-five percent (25%) of the fair market value of the gross assets of the Corporation determined as of the last day of the most recently ended fiscal year before the day on which the grant is made; provided, however, that Matthew Frank Moore Foundation is then in existence and then qualifies as an organization exempt from Federal income tax under the provisions of Section 501(c)(3) of the Code, and as may qualify contributions to such organization for deduction under Section 170(c)(2), Section 2055(a)(2) and Section 2522 of the Code; (iii) Thomas Burch, if he survives and is willing to serve, shall immediately become a Class A Member without further action of the Corporation; and (iv) Kelly Burch, if she survives and is willing to serve, shall immediately become a Class A Member without further action of the Corporation.

## **ARTICLE XII**

### **Dissolution; Distribution of Assets on Dissolution or Final Liquidation.**

**Section 1. Dissolution.** Subject to the exceptions set forth in Article XI, Section 2 above, the Corporation shall be dissolved upon the termination of the Class A Membership in the Corporation.

**Section 2. Distribution.** Upon the dissolution of the Corporation, and after payment, or provision is made for the payment, of all liabilities and debts of the Corporation, the remaining assets of the Corporation shall be distributed to the entity or the entities described below, provided that any such entity or entities must be, at the time of such distribution, organized and operated exclusively for public, charitable, religious, scientific, testing for public safety, literary or educational purposes, which purposes then qualify it for exemption from Federal income tax under the provisions of Section 501(c)(3) of the Code and as then qualify contributions to it for deduction under Section 170(c), Section 2055(a)(2), Section 2522 and Section 2106(a)(2) of the Code (any of which entities are hereinafter referred to as a "Qualified Entity"):

(a) If, at the time of such distribution, Martin J. Moore (the father of Mark B. Moore) is then living and serving as the Chairman of the Board of Directors of Moore Corporation, Inc., to Moore Foundation, Inc. so long as Moore Foundation, Inc. is a Qualified Entity at the time of such distribution; and

(b) If, at the time of such distribution, Martin J. Moore is not then living, or is not the Chairman of the Board of Directors of Moore Foundation, Inc. or Moore Foundation, Inc. is not then a Qualified Entity, fifty percent (50%) of the remaining assets shall be distributed to Moore Family Foundation and fifty percent (50%) of the assets shall be distributed to Matthew Frank Moore Foundation so long as both of such Corporations are Qualified Entities. If only one (1) of such two (2) Corporations is in existence or is a Qualified Entity at the time of the distribution of the assets of the Corporation, all of the remaining assets shall be distributed to the one (1) of those Corporations which is in existence and is a Qualified Entity at the time of the distribution of the Corporation's assets; and

(c) If no distribution can be made pursuant to (a) or (b) of this Section 2 of Article XII, the remaining assets of the Corporation shall be distributed to one (1) or more Qualified Entities as determined by the Board of Directors.

### Section 3. Disclosure.

(a) In conjunction with each annual meeting of the Board of Directors, each Disqualified Person shall be required to certify to the Board of Directors any relationship(s) which he or she has which may reasonably constitute a duality of interest, or a possible conflict of interest or which could give rise to a possible act of self-dealing, as described in Section 4941 of the Code.

(b) (i) Any possible duality of interest, conflict of interest or act of self-dealing on the part of any Disqualified Person shall be fully disclosed to the directors and made a matter of record, either through the annual procedure described in Sections 2 and 3(a) above, or in connection with any proposed transaction, arrangement or other matter of business being considered by the Board of Directors, when the issue arises.

(ii) Any Disqualified Person having a possible duality of interest, a conflict of interest or proposed act of self-dealing on any proposed transaction shall not vote or use personal influence with respect to the transaction, and he or she shall not be counted in determining the quorum for the meeting at which the proposed transaction is considered, even when otherwise permitted by law. The minutes of the meeting shall reflect that a disclosure was made, the abstention from voting, and the presence of a quorum. Investment interests, compensation and reimbursement issues addressed by the Board of Directors shall in all cases constitute a duality or conflict of interest issue.

(iii) Prior to engaging in any transaction which could involve a possible duality of interest, conflict of interest or other act of self-dealing with a Disqualified Person, the Corporation shall obtain an opinion from its counsel as to whether such transaction would constitute an act of self-dealing, which is prohibited by Section 4941 of the Code, and the Board of Directors shall decide by a majority vote of the directors present at the particular meeting whether a duality of interest, or a conflict of interest which could give rise to a possible act of self-dealing does or does not exist for purposes of the pending Board action.

(c) The requirements set forth in Section 3(b) shall not be construed as preventing a Disqualified Person from briefly stating his or her position on the proposed transaction, nor from answering pertinent questions of the Board of Directors.

(d) Each new director, officer and Corporation manager will be advised of the provisions of this Article X when entering into the duties of his or her office.

(e) Each director, officer and Corporation manager shall be required to provide information to other directors as to his or her outside activities and any other matters that might be considered as a possible duality of interest or a possible conflict of interest or which could give rise to an act of self-dealing.

(f) An individual is not prohibited from serving as a director, an officer or a Corporation manager if the Disqualified Person has a direct or indirect pecuniary interest in or derives a direct or indirect profit from a direct or indirect proposed transaction with the Corporation so long as, in the opinion of the Corporation's counsel, the proposed transaction would not give rise to an act of self-dealing, which is prohibited by Section 4941 of the Code. However, the Disqualified Person shall disclose that interest or profit in writing to the Board of Directors. The Disqualified Person shall in all cases abstain from voting on any matter that affects such interest or profit.
