During the year BDCI opened a thrift store selling donated clothes and other home furnishings. This store is staffed with volunteers and the proceeds will be used to help the community owned grocery store and other community businesses that need help to continue and serve the elderly population base.

Line 35 form 990-ez

BDCI is an all volunteer organization run for community betterment. Gaming and thrift store revenues are totally used for the express purposes set out in our bylaws. We feel these revenues are exempt from the filing of a 990-T based on the fact all ND gaming must be for charitable purposes and all other revenue come directly from donations to the organization.
