Marion County 4-H support: Objective is to support youth getting involved in agricultural activities to be better consumers or potential employees in the industry. Support provides awards for the various 4-H community clubs within the county. We also support the 4-H programs associated with the county fair including the livestock auction. Community 4-H leaders and several hundred 4-H members were involved and served. 14 board members and township representatives participated. Approximately 200 hours of board time was invested in this year round activity.

Farm Tours for Indy Parks: Objective is to help inner city youth gain a real world farm experience. The program pays for elementary age students in the Indy Parks summer program to experience a farm tour at Kelsey Farms. 1,022 children were served in 20 separate tours that were given. 5 volunteers from MCFB contributed approximately 50 hours toward this project.

Food check out week: Objective is to educate Indianapolis residents with relevant and factual information on food production and farming. The program is designed to be a week long public relations blitz to help Indianapolis area residents better understand where their food comes from. Radio ads were ran which reached over 100,000 people which directed listeners to a landing page with agricultural information. 300 people signed up for farm tours in this week long activity. Volunteers donated approximately 20 hours in this activity.
