The Rockford Health System employee Family Giving Campaign raised funds in 2010 for three uses an Employee Crisis Fund, the Wishbook catalogue of care and comfort items, and the Employee Education Fund The crisis fund provides assistance to employees who have experienced a crisis such as a fire or flood in their homes or the severe illness, traumatic injury or death of a spouse or child The Wishbook provides small items for care-giving departments throughout Rockford Health System The Employee Education Fund expands opportunities for employees to attend training and skills development seminars RMDF donations were also used to assist Visiting Nurses Association to care for the elderly, the homebound, the recovering, and the dying In 2010 some specific donations were also made for hospice care

Through charitable contributions, RMDF supports the Ronald McDonald Care Mobile, staffed and operated by RMH, which provides free medical and dental care to uninsured and underinsured children in five counties at 12 different sites in Northern Illinois The Care Mobile visits included vaccinations, lead and/or blood screenings, medical diagnoses, preventative and restorative dental care and treatment/care to avoid an emergency room visit RMDF donations from the Auxiliary provided some of the Care Mobile funding as well as funds for supplies and education materials for the pediatric and pediatric intensive care units, health and wellness resources for patients, nursing scholarships for minority students, the Healing Harp program that creates an atmosphere of care and comfort for hospitalized patients, a video program in both English and Spanish that helps parents provide care for their newborn babies, and other support for the system
