Second Harvest Northern Lakes Food Bank rescued 3,927,775 pounds of food and grocery product from national and regional manufactureres, wholesalers, retailers and growers for distribution to over 200 non-profit programs (soup kitchens, food shelves and other chantable programs) as well as in-need people directly throughout NE Minnesota (St Louis, Carlton, Lake and Cook counties) and NW Wisconsin (Douglas, Bayfield, Ashland and Iron counties) We accomplished this utilizing 9,515 hours of volunteer service (the equivalent of 4 5 full-time positions) from over 500 volunteers which saves our food bank over \$105,000 in staff expense In all, our food bank distributed 3,965,390 pounds of food, or enough food for 3,172,312 meals, which fed approximately 43,000 Northland residents in need
