Koinonia House of DuPage County, Inc., d/b/a Koinonia House of Wheaton (KHW)

Provide a Christian family home-based discipleship program (lasting about 15 months) for men recently released from prison.

KHW can work with up to four residents at one time.

Highlights for FY2010 include the November graduation of one of the KHW residents after completing his 15-month program.

The total direct beneficiaries for FY2010 is five men who were discipled through the KHW. Indirect beneficiaries include immediate family members with whom the men are reconciling and rebuilding relationships. Other indirect beneficiaries include the members of the four mentoring churches who provided discipleship, friendship, and ministry opportunities to the KHW residents.

Meet Me at the Gate (MMATG)

Train and equip the Church to minister to Christians coming out of prison; identify and train individuals interested in establishing post-prison ministries of their own; work with local, state, and federal officials and persons within the the Department of Corrections to facilitate prison reform; educate the general public concerning the need for post-prison ministry.

Highlights for FY2010 include a presentation/training for the launching of Philemon Ministries in Georgetown, DE. The executive director and admin. assistant met with State of Delaware Corrections officials, prison ministry workers and church representatives.

The executive director also introduced the MMATG concept to church officials while he ministered in a foreign country.

In-Prison Ministries

Educate, motivate, and minister to incarcerated persons to prepare them for potential release into society.

FY2010 activities include conducting over 32 services in 11 prisons and jails in IL, LA, NC, TN, VA, and WV.

A special highlight was the service at the Federal Correctional Institute in West Virginia in July, which was a result of KHN's working with a family whose husband/father is incarcerated there.
