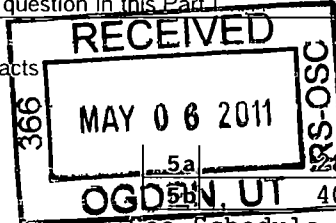

The JCS-Weil Trust contributes funds to the Jewish Chautauqua Society, which provides education courses for credit at colleges and universities on subjects involving Jews and Judaism and distributes Judaica to libraries.
