In accordance with the terms of the trust document establishing the Foundation, the Mary Heath Foundation makes grants to qualifying tax-exempt organizations sponsoring projects and activities in the areas of:

Public Health
Public Safety
Public Recreation
Public Education

To be considered for a Heath Grant, the applying organization must be physically located in the State of Illinois, and the organization's project or activity must be for the direct benefit and enjoyment of the general public in the State of Illinois.

- **Programs and projects that are consistent with the stated purposes of the Mary Heath Foundation**
- **The Foundation will monitor the impact of all grants to help determine the future direction and practices of the grant process**
