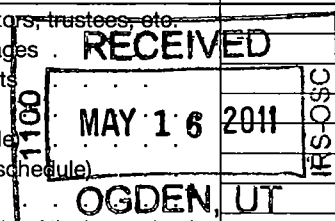

The Emily Baker Trust was created by the Last Will and Testament of Emily B. Baker, deceased. The Will is dated August 13, 1957. Emily B. Baker died May 8, 1951, and her Will was admitted to probate in McLean County, Illinois, on June 30, 1953. The Will left the decedent's 100 acre farm in Trust in perpetuity for the benefit of two charitable beneficiaries. The trustee does not have the authority under the Will to sell the farm or to distribute principal to the charitable beneficiaries. The trustee only has the authority to manage the farm and to distribute the net income annually, which the trustee has done since the Trust was established over fifty years ago. The charitable beneficiaries have a present and a future interest in the farm. Therefore, the fair market value of the farm must be excluded from determining the minimum investment return and distributable amount in Parts X and XI. Again, the entire net income of the Trust has been distributed to the charitable beneficiaries for over fifty years and will continue to be so distributed in perpetuity.
