This requires the Manual High School Alumni Association to meet with the head of the Manual Counseling Center to determine those students being charted for graduation within the required range of grade point average. Preliminary arrangements are made for the interview of students in April, either on the second or fourth Tuesday and Wednesday, depending on the time of the school's Easter or spring break.

The interview of students is made by two persons from each of the 25 and 50 year anniversary classes, two members of the Manual High School alumni board, and the MHSAA secretary-treasurer who handles the process, having first introduced the student and interviewers to each other. At the end of the two days of interviews, the selection is made by the interviewers voting for three selection of Alumni Memorial awards, the ITA (Academy of the old Industrial Arts Dept.), and then the balance of regular Alumni Association scholarships. The voting process is continued until all selections have been made and two applicants are determined as alternates, who become eligible when a student changes his mind and does something else, such as enter the Military or forfeits his scholarship for whatever reason.

There are also scholarships for second-year student scholarship winners, who are notified on May 1 that there are some funds available for those persons who have completed the first year with 30 credit hours, maintained a grade point average of 2.5 on a 4. scale, and have enrolled for the fall semester. They are required to furnish evidence of enrollment and transcript of grades with their application blanks.
